BULGARIAN TRADE WITH THIRD COUNTRIES FOR THE PERIOD JANUARY - JULY 2011 (PRELIMINARY DATA)

In the period January - July 2011 the Bulgarian exports to third countries increased by 35.1% compared to the corresponding period of the previous year and exceeded 8.6 billion levs (Table 1.1 and 1.2). The main trade partners of Bulgaria were Turkey, Serbia, Russia, The former Yugoslav Republic of Macedonia and China, that formed 47.1% of the total exports to non EU countries (Table 2). The exports to South Africa and Canada increased significantly. Falls were reported on the exports to Syria, Singapore, Peru, Indonesia, United Arab Emirates, Albania, Viet Nam and Serbia.

In July 2011 the exports to third countries increased by 32.7% compared to the corresponding month of the previous year and exceeded 1.3 billion levs.




Figure 1. Nominal growth of exports to non EU countries for the period 2009 - 2011 (Compared to the same month of the previous year)

Bulgarian **imports from third countries** in the first seven months of 2011 increased by 24.2% compared to the corresponding period of the previous year and **amounted to 10.5 billion levs (at CIF prices)** (Tables 1.1 and 1.2). The most significant growths were reported on the imports from Kazakhstan, United Arab Emirates, South Africa, Republic of Korea and Singapore(Table 2). The largest decreases were observed in the imports from Peru, Egypt and Viet-Nam.

In July 2011 the Bulgarian imports from third countries increased by 6.6% compared to the corresponding month of the previous year and reached 1.5 billion levs.




Figure 2. Nominal growth of imports to non EU countries for the period 2009 - 2011 (Compared to the same month of the previous year)

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - July 2011 was negative and reached 1905.8 million levs (Table 1.1). The trade balance at FOB /FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 1352.6 million levs.

In July 2011 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and reached 141.6 million levs.

The exports of Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, increased in the most of the sections in the first seven months of 2011 compared to the corresponding period of the previous year (Table 3). The largest growths were recorded in the sections: "Animal and vegetable oils, fats and waxes"¹, "Mineral fuels, lubricants and related materials" and "Crude materials, inedible (except fuel)"². The most notable fall was observed in section "Miscellaneous manufactured articles"³.

The largest growths in imports from third countries were reported in section "Chemical and related products" and the most significant falls were reported in section "Crude materials, inedible (except fuel)".



Bulgarian trade with third countries and EU - total

In the period January - July 2011 the total value of the exported goods amounted to 22.4 billion levs. Compared to the corresponding period of 2010 the exports increased by 36.9% (Table 1.1 and 1.2).

In July 2011 **the total exports amounted to 3.6 billion levs** and increased by 21.1% compared to the corresponding month of the previous year.




The total value of all imported goods in the period January - July 2011 was 24.8 billion levs (at CIF prices), or by 21.8% more than corresponding period of the previous year (Table 1.1 and 1.2).

In July 2011 **the total imports increased by 12.7%** compared to the corresponding month of the previous year and reached 3.7 billion levs.

The total foreign trade balance (exports FOB - import CIF) was negative in the period January – July 2011 and amounted to 2362.1 million levs which was 1608.4 million levs less than the balance in the first seven months of 2010 (Table 1.1 and 1.2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the total foreign trade balance was also negative and amounted to 1155.0 million levs.

In July 2011 the total foreign trade balance (**exports FOB** - **import CIF**) was negative and amounted to 89.8 million levs. The trade balance at FOB/FOB prices was positive and reached 99.2 million levs.
