




## BULGARIAN TRADE WITH THIRD COUNTRIES FOR THE PERIOD JANUARY - MARCH 2012 (PRELIMINARY DATA)

In the period **January - March 2012** the Bulgarian **exports to third countries** decreased by 1.0% compared to the corresponding period of the previous year and **amounted to 3.6 billion Levs** (Table 1.1 and 1.2). The main trade partners of Bulgaria were Turkey, China, Russia, Serbia, The Former Yugoslav Republic of Macedonia and United Arab Emirates, that formed 51.0% of the total exports to non EU countries (Table 2). The exports to United Arab Emirates, Canada, Brazil and Syria increased significantly. The most significant falls were reported on the exports to Singapore, India, South Africa and Croatia.

In March 2012 the exports to third countries increased by 2.0% compared to the corresponding month of the previous year and amounted to 1.3 billion Levs.






Bulgarian imports from third countries in the first three months of 2012 increased by 9.9% compared to the corresponding period of the previous year and amounted to 4.5 billion Levs (at CIF prices) (Tables 1.1 and 1.2). The most significant growths were reported on the imports from Bosnia and Herzegovina, Iran, Taiwan and Viet-Nam (Table 2). The largest decreases were observed in the imports from Kazakhstan, Ukraine and Israel.

**In March 2012** the Bulgarian imports from third countries increased by 12.2% compared to the corresponding month of the previous year and **exceeded 1.6 billion Levs.** 









The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - March 2012 was negative and amounted to 904.9 million Levs (Table 1.1). The trade balance at FOB /FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 681.1 million Levs.

**In March 2012** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and amounted to 351.7 million Levs.

In the **first three months of 2012** compared to the corresponding period of the previous year, the largest growth **in the exports** of Bulgaria to third countries, distributed according to the Standard International Trade Classification (Table 3) was recorded in the section "Animal and vegetable oils, fats and waxes". The most notable fall was observed in section "Mineral fuels, lubricants and related materials".

The largest growth **in imports from third countries** was reported in section "Machinery and transport equipment" and the most significant fall was reported in section "Beverages and tobacco".

## Bulgarian trade with third countries and EU - total

In the period January - March 2012 the total value of the exported goods reached 9.0 billion Levs. Compared to the corresponding period of 2011 the exports decreased by 3.3% (Table 1.1 and 1.2).

In March 2012 the total exports exceeded 3.3 billion Levs and increased by 1.6% compared to the corresponding month of 2011.




Figure 3. Nominal growth of exports for the period


The total value of all imported goods in the period January - March 2012 were for 11.2 billion Levs (at CIF prices), or by 8.9% more than corresponding period of the previous year (Table 1.1 and 1.2).

In March 2012 the total imports increased by 11.5% compared to the corresponding month of the previous year and amounted to **4.2 billion Levs**.

The total foreign trade balance (exports FOB - import CIF) was negative in the period January – March 2012 and amounted to 2110.3 million Levs which was 1222.1 million Levs more than the balance in the first three months of 2011 (Table 1.1 and 1.2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January – March 2012 the total foreign trade balance was also negative and amounted to 1570.7 million Levs.

In **March 2012** the total foreign trade balance (exports FOB - import CIF) was negative and amounted to 847.7 million Levs. The trade balance at **FOB/FOB** prices was also negative and reached 639.3 million Levs.
