

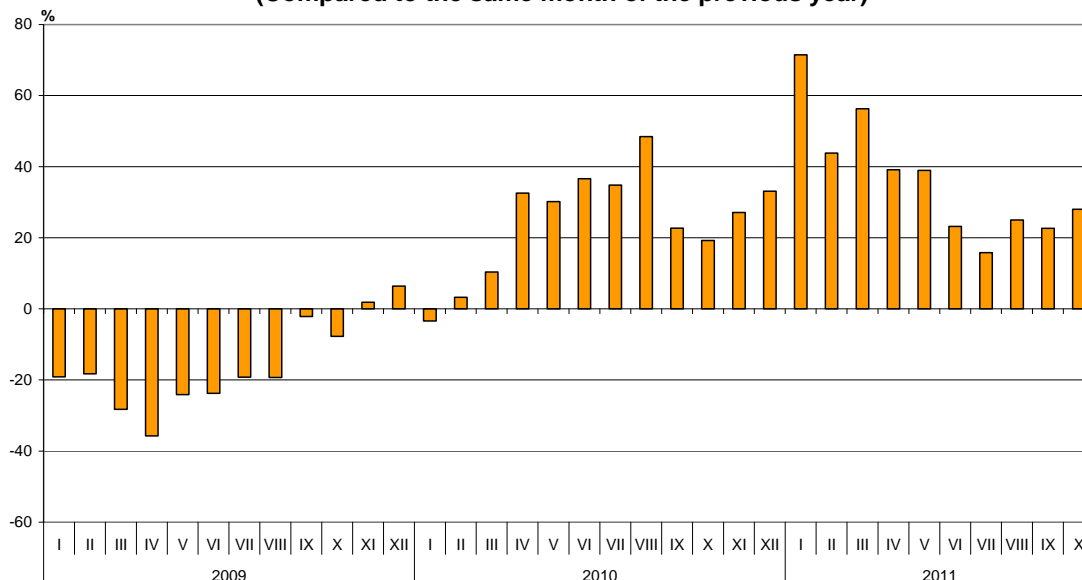


## BULGARIAN TRADE WITH EU FOR THE PERIOD JANUARY - OCTOBER 2011 (PRELIMINARY DATA)

In the period **January - October 2011** the Bulgarian **exports** to the **EU** increased by 33.8% compared to the corresponding period of the previous year and amounted to 20.4 billion leva (Table 1.1 and 1.2). The main trade partners of Bulgaria were Germany, Romania, Italy, Greece and Belgium, that formed 66.7 % of the total exports to the EU Member states (Table 2). The most significant growths were observed in the exports to Malta and Denmark. Falls were registered in the exports to Slovenia and Luxembourg.

In **October 2011** the exports to the EU increased by 28.0% compared to the corresponding month of the previous year and exceeded 2.2 billion leva.

(Compared to the same month of the previous year)**

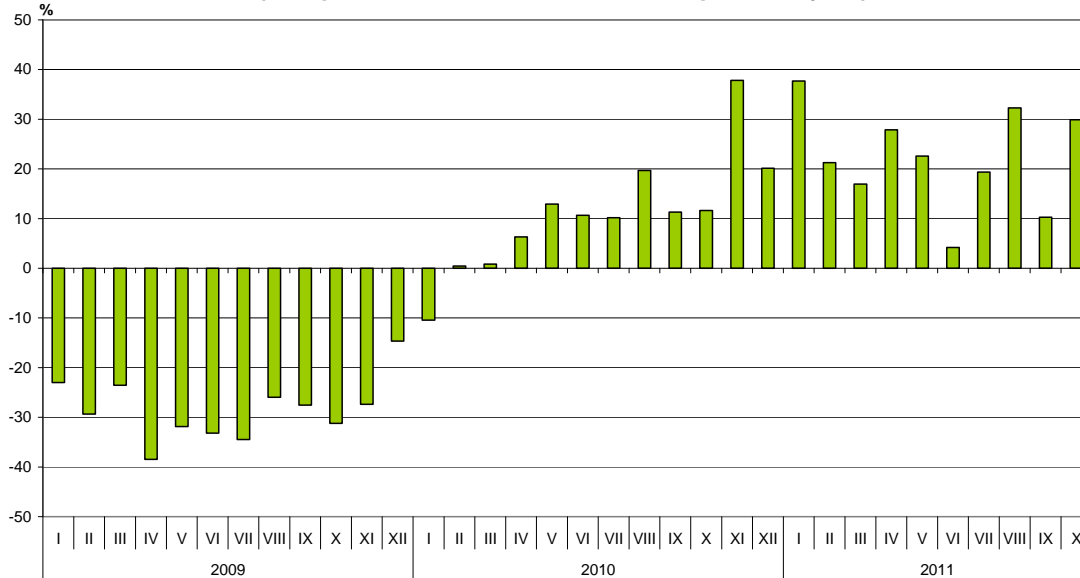


Bulgarian **imports** from the **EU** in the period **January - October 2011** increased by 21.6% compared to the corresponding period of the previous year and amounted to 21.4 billion leva at CIF prices (Tables 1.1 and 1.2). The most significant growths were reported on the imports from Cyprus and Spain (Table 2). Decreases were observed in the imports from Malta, Finland, Portugal and Denmark.

In **October 2011** the Bulgarian imports from the EU Member States increased by 29.9% compared to the corresponding month of the previous year and exceeded 2.6 billion leva at CIF prices.

The **foreign trade balance** of Bulgaria (export FOB - import CIF) with **EU** in the period January - October 2011 was negative and amounted to 1025.8 million levs (Table 1.1). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the trade balance was also negative and amounted to 45.6 million levs.

The **exports** of Bulgaria to the **EU** distributed according to the **Standard International Trade Classification**, increased in all sections in the first ten months of 2011 compared to the corresponding period of the previous year (Table 3). The largest growths were recorded in the sections “Crude materials, inedible (except fuels)”<sup>1</sup>, “Chemical and related products”, and „Animal and vegetable oils, fats and waxes”<sup>2</sup>

The largest growths **on imports** from EU were reported in sections "Crude materials, inedible (except fuels)" and „Animal and vegetable oils, fats and waxes”.
