


Trips of Bulgarian residents abroad and arrivals of visitors from abroad to Bulgaria in March 2009

In March 2009 the trips of Bulgarian residents abroad were 403 718 and decreased by 15.1% in comparison with March 2008 (Annex 1). A decrease has been registered in the number of trips for almost all countries. The highest reduction was in the travels to Denmark - by 69.1%, Japan - by 67.6%, Finland - by 56.9%, Malta - by 56.4%, Slovenia - by 53.3%, Slovakia - by 41.5%, Italy - by 38.7%, Czech Republic - by 37.2% and other countries. More trips in comparison with the same month of 2008 were recorded only to Turkey - 18.4%.

The greatest share of the total trips of the Bulgarian residents travelling abroad was with professional purpose - 54.3%, followed by trips with "holiday and recreation" purpose - 22.9%, visits as guests - 19.7% and other purposes - 3.1%.

Arrivals of visitors from abroad to Bulgaria in March 2009 were 334 417 and decreased by 7.3% in comparison with the same month of 2008 (Annex 2). A reduction was registered in the number of visits reported by almost all countries.


Concerning Member – States of the European Union, the highest decrease of the number of visits was observed for citizens of Malta - by 37.6%, United Kingdom - by 28.7%, Denmark - by 26.0%, Portugal - by 18.7%, Sweden - by 12.4%, Italy - by 9.0%. At the same time more significant an increase was registered of arrivals from Romania - by 7.3%, Germany - by 2.6%, Hungary - by 2.2%.

A reduction of the number of visits by citizens of all countries included it the group of "Other European countries"¹ was registered the highest drop was observed from Norway - by 46.4%,

¹ Group of "Other European countries" include countries in Europe outside EU.

Serbia - by 31.8% and Turkey - by 19.2%. Compared to the same month of 2008 an increase of the number of the visits of citizens from Japan - by 8.4% and Israel - by 7.0% have been registered.

In March 2009 arrivals with a purpose "holiday and recreation" (35.6%) composed the greatest share of the total number of foreigners' visits to Bulgaria, followed by "transit" purpose - 30.8%, professional purpose - 21.5%, other purposes - 10.1%, and visits as guests - 2.0%.

Methodological notes

Statistical data on the trips of Bulgarian citizens abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis on the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing bulgarian and foreign citizens on the border check points.
