


Arrivals of visitors from abroad to Bulgaria and trips of Bulgarian residents in abroad in August 2009

In August 2009, the number of arrivals of visitors from abroad to Bulgaria was 1 434.6 thousand or 10.1% less than the number of trips in the same month of 2008 (Annex 1).

In respect to EU Member States less visits were observed for citizens of Malta - by 91.3%, Sweden - by 72.5%, Denmark - by 65.0%, Slovakia - by 60.0% and Finland - by 51.4%. At the same time, a significant increase of arrivals was registered from Spain - by 96.2%, Czech Republic - by 61.1%, Italy - by 60.8%, Greece - by 60.0%, France - by 52.3%, Slovenia - by 33.6%.

In the group of "Other European countries" the highest drop was observed in the number of visits of citizens from Turkey - by 60.0%, Norway - by 36.1% and Serbia - by 33.5%. At the same time the increase in the number of visits of citizens from Israel was seen - by 37.2% and from Canada - by 12.0%.

In August 2009, arrivals with holiday and recreation purpose composed the greatest share of the total number of foreigners' visits to Bulgaria - 62.5%, followed by transit purpose - 26.1%, other purposes - 5.5%, professional purpose - 4.7%, and visits as guests - 1.2%.

In August 2009 the number of arrivals of visitors with holiday and recreation purpose was 896.8 thousand, and the largest number of tourists came from Germany - 175.5 thousand, Romania - 81.4 thousand, Poland - 78.6 thousand and Czech Republic - 67.6 thousand. Within arrivals with transit purpose, the highest number of arrivals reported the Romanian citizens which were 77.0 thousand, followed by the citizens of Turkey - 76.5 thousand, Germany - 48.0 thousand, Austria - 23.5 thousand.


The number of the trips of Bulgarian residents in abroad was 547.1 thousand in August 2009, which was 7.7% less than the number of the trips in August 2008 (Annex 2).

As compared to the same month of 2008 an increase in the total number of the trips was

registered, namely to: Macedonia - by 24.6%, Greece - by 7.5% and Romania - by 0.4%. At the same time, a decrease was registered in the number of the trips for all other observed countries. The highest decline was observed in the trips to Japan - by 61.4%, Finland - by 57.6%, Sweden - by 56.8%, Czech Republic - by 54.4%, Slovenia - by 50.1%, Italy - by 47.6%, Austria - by 45.5%, followed by, Denmark - by 45.4%, Norway - by 43.1%, Spain - by 42.3%, France - by 40.1%, Netherland - by 39.9%, Malta - by 39.0%, Cyprus - by 38.8%, Israel - by 37.7%.

The highest share of the trips of the Bulgarian citizens travelling abroad had the trips with professional purpose - 46.5%, followed by trips with holiday and recreation purpose - 28.5%, visits as guests - 19.4% and other purposes - 5.6%.

In August 2009, the Bulgarian residents made 155.9 thousand trips with holiday and recreation purpose mostly to neighboring countries- to Greece - 61.2 thousand, to Serbia - 20.8 thousand, to Romania - 19.4 thousand and to Turkey - 17.5 thousand.

Methodological notes

The statistical data on travel of Bulgarian residents abroad and on visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and from a sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border crossing control points.

Data on the number of the trips of the citizens of the European Union are estimates based on the information received from the Ministry of Interior and the airport authorities. Data on the number of third country citizens are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens through country's border crossing control points.
