




BULGARIAN TRADE WITH EU IN THE PERIOD JANUARY - AUGUST 2017 (PRELIMINARY DATA)

In the period **January - August 2017** Bulgarian **exports to the EU** increased by 11.0% compared to the same period of 2016 and added up to 22 401.6 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Italy, Romania, Greece, France and Belgium which accounted for 67.9% of the exports to the EU Member States (Annex, Table 3).

In **August 2017** the exports to the EU grew by 9.4% compared to the corresponding month of the previous year and amounted to 2 932.9 Million BGN.

In the period **January - August 2017** compared to the corresponding period of the previous year the largest growths in the exports of Bulgaria to the EU distributed according to the **Standard International Trade Classification** (Annex, Table 4) were recorded in the sections 'Mineral fuel, lubricants and related materials' (32.0%) and 'Manufactured goods classified chiefly by material²' (29.2%). The most notable fall




was recorded in sections 'Beverages and tobacco' (13.1%) and 'Crude materials, inedible (except fuel)' (10.3%).

Bulgarian **imports from the EU** in the period **January - August 2017** increased by 10.9% compared to the same period of 2016 and added up to 24 193.4 Million BGN at CIF prices (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Italy, Romania, Spain and Greece (Annex, Table 3).

In **August 2017** the Bulgarian imports from the EU Member States grew by 12.3% compared to the corresponding month of the previous year and amounted to 3 129.3 Million BGN.

In the period **January - August 2017** compared to the corresponding period of 2016 the largest growths in imports from the EU distributed according to the **Standard International Trade Classification** were reported in the sections 'Crude materials, inedible (except fuel)' (53.0%) and 'Mineral fuel, lubricants and related materials' (34.1%) while the largest fall was observed in section 'Beverages and tobacco' (3.0%).

The **foreign trade balance** of Bulgaria (**export FOB - import CIF**) with the **EU** in the period **January - August 2017** was negative and added up to 1 791.8 Million BGN (Annex, Table 1). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the trade balance was also negative and amounted to 632.9 Million BGN.
