



PRODUCER PRICE INDICES IN INDUSTRY^{1,2}, JULY 2020

1. Total Producer Price Indices in Industry³

The Total Producer Price Index in Industry in July 2020 increased by 2.4% compared to the previous month. Higher prices were registered in the mining and quarrying industry by 4.8%, in the electricity, gas, steam and air conditioning supply by 3.2% and in manufacturing by 2.1%.

In manufacturing, prices went up in the manufacture of basic metals by 10.3% and in the manufacture of tobacco products by 1.1%. More significant decrease in prices was reported in manufacture of leather and related products and in the manufacture of beverages - both by 0.6%.

The Total Producer Price Index in July 2020 decreased by 2.1% compared to the same month of 2019. The prices fell in manufacturing by 3.0%, in the electricity, gas, steam and air conditioning supply by 0.5%, while in the mining and quarrying industry the prices rose by 4.3%.

In manufacturing, significant decreases in prices were seen in the manufacture of wood and of products of wood and cork, except furniture and manufacture of articles of straw and plaining materials by 3.5%, in the manufacture of paper and paper products by 3.0% and in the manufacture of rubber and plastic products by 2.2%. More compelling increase in prices was reported in the manufacture of leather and related products by 3.9%, in the manufacture of basic metals by 3.8%, and in the manufacture of tobacco products by 3.5%.

¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.


² In the text are not quoted the activities that are confidential according to the Law on Statistics and in this way they are statistical secrecy.

³ Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

2. Producer Price Indices on Domestic Market¹

Producer Price Index on Domestic Market in July 2020 increased by 1.6% compared to the previous month. The domestic prices went up in the mining and quarrying industry by 5.0%, in the electricity, gas, steam and air conditioning supply by 3.0%, and in manufacturing by 0.5%.

In the manufacturing, compared to the previous month the prices went up in the manufacture of basic metals by 4.3%, in other manufacturing and in the manufacture of leather and related products - both by 0.4%. More significant decrease in the domestic prices was seen in the manufacture of wearing apparel by 0.7%, in the manufacture of beverages and the manufacture of furniture - both by 0.6%.

¹ Producer Price Indices on domestic market are calculated at constant base (2015) weighed with turnover structure on domestic market.






Producer Price Index on Domestic Market in July 2020 decreased by 0.7% compared to the same month of 2019. Prices went down in manufacturing by 1.9% while the prices rose in the mining and quarrying industry by 2.7%, and in the electricity, gas, steam and air conditioning supply by 0.4%.

In manufacturing compered to July 2019, the prices fell in the manufacture of basic metals and in the manufacture of paper and paper products - both by 2.1%. More compelling price increase was reported in the manufacture of motor vehicles, trailers and semi-trailers by 5.3% and in the manufacture of leather and related products by 4.1%.

3. Producer Price Indices on Non-domestic Market¹

Producer Price Index on Non-domestic Market in July 2020 rose by 3.8% compared to the previous month and fell by 4.2% compared to the same month of 2019.

¹ Producer Price Indices on non-domestic market are calculated at constant base (2015) weighed with turnover structure on non-domestic market.
