



## PRODUCER PRICE INDICES IN INDUSTRY<sup>1,2</sup>, DECEMBER 2020

# 1. Total Producer Price Indices in Industry<sup>3</sup>

The Total Producer Price Index in Industry in December 2020 increased by 1.9% compared to the previous month. Higher prices were registered in mining and quarrying industry by 2.6%, in manufacturing by 2.0%, and in the electricity, gas, steam and air conditioning supply by 1.6%.

Prices went up significantly in the manufacture of basic metals by 9.0% and in the manufacture of chemicals and chemical products by 2.1%. Prices fell more compellingly in the manufacture of paper and paper products by 0.6% and in the manufacture of beverages by 0.5%.

The Total Producer Price Index in December 2020 decreased by 0.7% compared to the same month of 2019. The prices fell in manufacturing by 1.6%, in the electricity, gas, steam and air conditioning supply by 0.4%, while in the mining and quarrying industry the prices rose by 15.2%.

In manufacturing, significant decreases in prices were seen in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 2.6%, and in the manufacture of paper and paper products by 2.1%. More compelling increase in prices was reported in the manufacture of basic metals by 7.1%, in the manufacture of food products by 3.6%.

<sup>&</sup>lt;sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.



<sup>&</sup>lt;sup>3</sup> Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

#### 2. Producer Price Indices on Domestic Market<sup>1</sup>

**Producer Price Index on Domestic Market** in December 2020 increased by 1.0% compared to the previous month. The domestic prices went up in the mining and quarrying industry by 3.9%, in the electricity, gas, steam and air conditioning supply by 1.2% and in the manufacturing by 0.7%.

In the manufacturing, compared to the previous month prices went up in the manufacture of basic metals by 7.4% and in manufacture of chemicals and chemical products by 2.7%. The prices went down in the manufacture of beverages by 0.5% and in the manufacture of electrical equipment by 0.3%.

**Producer Price Index on Domestic Market** in December 2020 decreased by 0.5% compared to the same month of 2019. Prices went down in manufacturing by 1.2% and in the electricity, gas, steam and air conditioning supply by 0.7%, while the prices rose in the mining and quarrying industry by 9.8%.

In manufacturing compared to December 2019, the prices fell in the manufacture of wearing apparel by 2.3% and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 2.0%. More compelling price increase was reported in the manufacture of basic metals by 6.3% and in manufacture of food products by 3.5%.




Figure 2. Producer Price Indices on Domestic Market in Industry (2015 = 100)

### 3. Producer Price Indices on Non-domestic Market<sup>1</sup>

**Producer Price Index on Non-domestic Market** in December 2020 increased by 3.2% compared to the previous month and decreased by 1.1% compared to the same month of 2019.
