



# PRODUCTION AND DELIVERIES OF ENERGY PRODUCTS, MAY 2021

#### **Production of energy products**

In May 2021 compared to April 2021 an increase is reported for the production of:

- solid fuels by 29.6% to 2 393 thousand tonnes;
- liquefied petroleum gases by 20.0% to 6 thousand tonnes;
- unleaded motor gasoline by 93.5% to 120 thousand tonnes;
- transport diesel by 45.6% to 246 thousand tonnes.

A decrease is reported for the production of:

- natural gas by 33.3% to 2 million m<sup>3</sup>;
- electricity by 13.6% to 3 342 GWh (Annex, Table 1).

In May 2021 compared to the same month of the previous year, an increase is reported for the production of:

- solid fuels by 95.0%;
- liquefied petroleum gases by 20.0%;
- unleaded motor gasoline by 90.5%;
- transport diesel by 86.4%;
- electricity by 22.2%.

A decrease is reported for the production of:

• natural gas - by 50.0%.

#### **Deliveries of energy products**

In May 2021 compared to April 2021 an increase is reported for the deliveries of:

• solid fuels - by 27.5% to 2 441 thousand tonnes.

A decrease is reported for the deliveries of:

- liquefied petroleum gases by 2.9% to 33 thousand tonnes;
- unleaded motor gasoline by 30.6% to 34 thousand tonnes;
- transport diesel by 12.0% to 191 thousand tonnes.
- natural gas by 20.4% to 234 million m<sup>3</sup>;
- electricity by 14.0% to 2 448 GWh (Annex, Table 2).

In May 2021 compared to the same month of the previous year, an increase is reported for the deliveries of:

- solid fuels by 89.8%;
- transport diesel by 17.2%;
- natural gas by 26.5%;
- electricity by 4.4%.

A decrease is reported for the deliveries of:

- liquefied petroleum gases by 8.3%;
- unleaded motor gasoline by 20.9%.





#### Methodological notes

The survey on energy products is conducted every month in accordance with the Regulation (EO) No. 1099/2008 of the European Parliament and of the Council of 22 October 2008 on energy statistics, and its amendments. The survey aims to submit information on the production and inland deliveries of the main energy products - electricity, solid fuels, natural gas and petroleum products. The reporting units are producers, importers and exporters of energy products. Production and deliveries of the energy products are the main observed indicators.

#### Solid fuels

*Production* - includes Hard coal, Lignite and Solid fuels from coal. Producers report quantities calculated after any operation for the removal of inert matter.

*Deliveries* - quantities delivered to the internal market. They are equal to the total of the deliveries to the different types of consumers: producers' own use, main activity power stations, coking plants and patent fuel plants, industry, iron and steel industry and others.

Since 1.01.2017 Brown coal briquettes have been excluded from the monthly survey.

### **Petroleum products**

Production - includes production of finished products at a refinery or blending plant.

*Deliveries* - wholesale deliveries to the domestic market of finished petroleum products from producers, importers/exporters.

Deliveries of petroleum products are defined as: primary product receipts + gross refinery output + recycled products - refinery fuel + imports - exports - international marine bunkers + interproduct transfers - products transferred - stock changes.

#### Natural gas

*Production* - includes all dry marketable production within national boundaries, including offshore production. Production is measured after purification and extraction of NGLs and sulphur. Excludes extraction losses and quantities reinjected, vented or flared. Includes quantities used within the natural gas industry; in gas extraction, pipeline systems and processing plants.

Deliveries - total natural gas, distributed for the internal market, including own use and losses.

Data are presented in million cubic meters assuming reference gas conditions 15°C and 101.325 kPa.

To convert quantities from cubic meters at 20°C to cubic meters at 15°C - according to the reporting requirements of Regulation (EC) No. 1099/2008 of the European Parliament and of the Council on energy statistics, we use a conversion factor of 0.98294.

#### **Electricity**

*Production* - includes produced electricity from Thermal power plants, Nuclear power plants, Hydro power plants, Pumped storage plant and electricity, obtained from wind generators and solar panels. *Deliveries* - the sum of the net produced electricity and net import.




Figure 2. Production and deliveries of liquefied petroleum gases








Figure 3. Production and deliveries of unleaded motor gasoline








Figure 5. Production and deliveries of natural gas




Figure 6. Production and deliveries of electricity
