

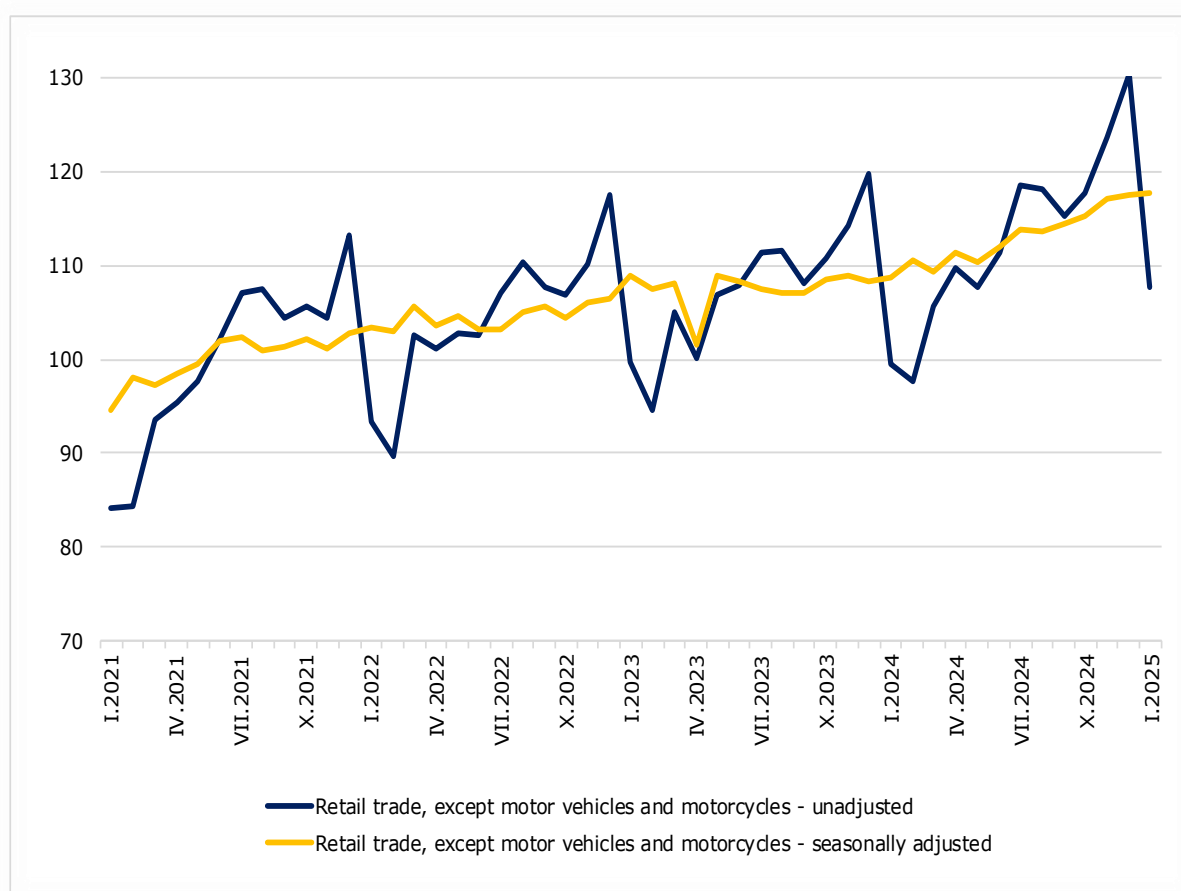


### TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT MOTOR VEHICLES AND MOTORCYCLES', JANUARY 2025

In January<sup>1</sup> 2025, the turnover in 'Retail trade, except motor vehicles and motorcycles' at constant prices kept its level from the previous month. The data are preliminary and seasonally adjusted.

The trade turnover rose by 8.1% compared to the same month of 2024 according to the calendar-adjusted data.

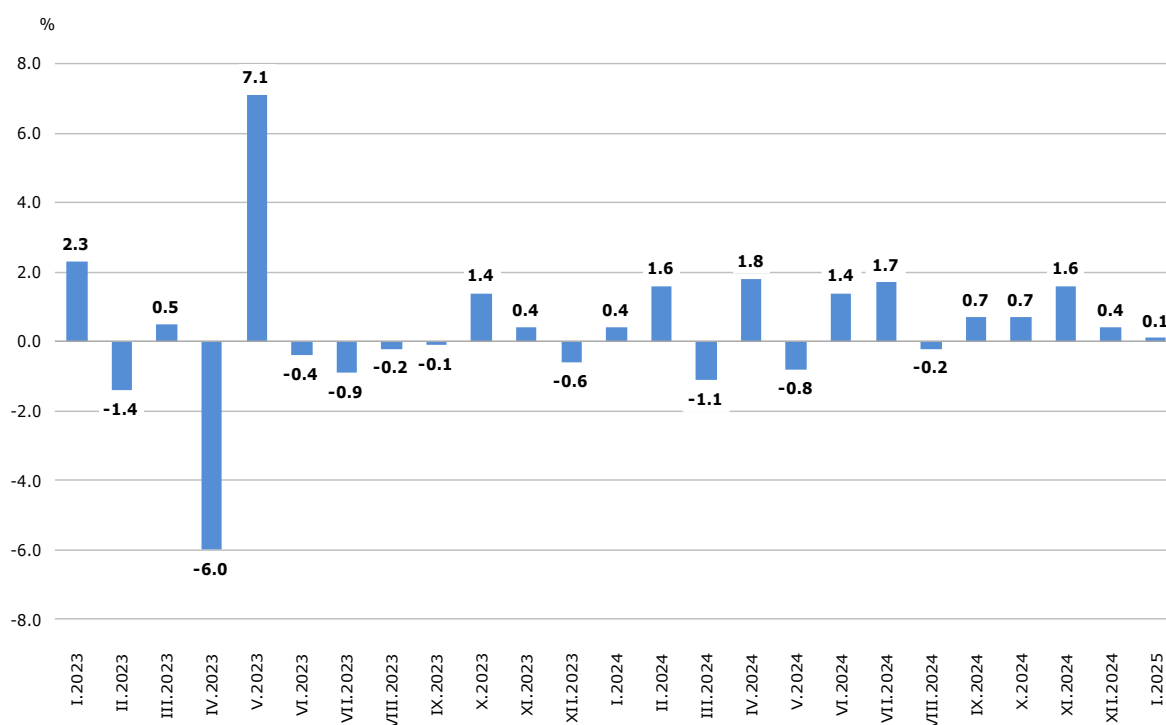
## TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT MOTOR VEHICLES AND MOTORCYCLES', JANUARY 2025

### Monthly changes

In January 2025, a growth was reported in 'Retail sales of automotive fuel in specialised stores' - by 9.2% and in 'Retail sales of non-food products (except fuel)' - by 0.2%. A decrease was registered in 'Retail sales of food, beverages and tobacco' - by 2.7%.

In the group 'Retail sales of non-food products (except fuel)', a major rise was observed in the following subgroups: 'Retail sales of computers, peripheral units and software; telecommunications equipment' - by 3.8%, 'Retail sale of audio and video equipment; hardware, paints and glass; electrical household appliances' - by 3.3%, and 'Retail sale in non-specialised stores' - by 3.1%. A decrease was registered in 'Retail sale via mail order houses or via Internet' - by 4.9%.

(Seasonally adjusted data)**



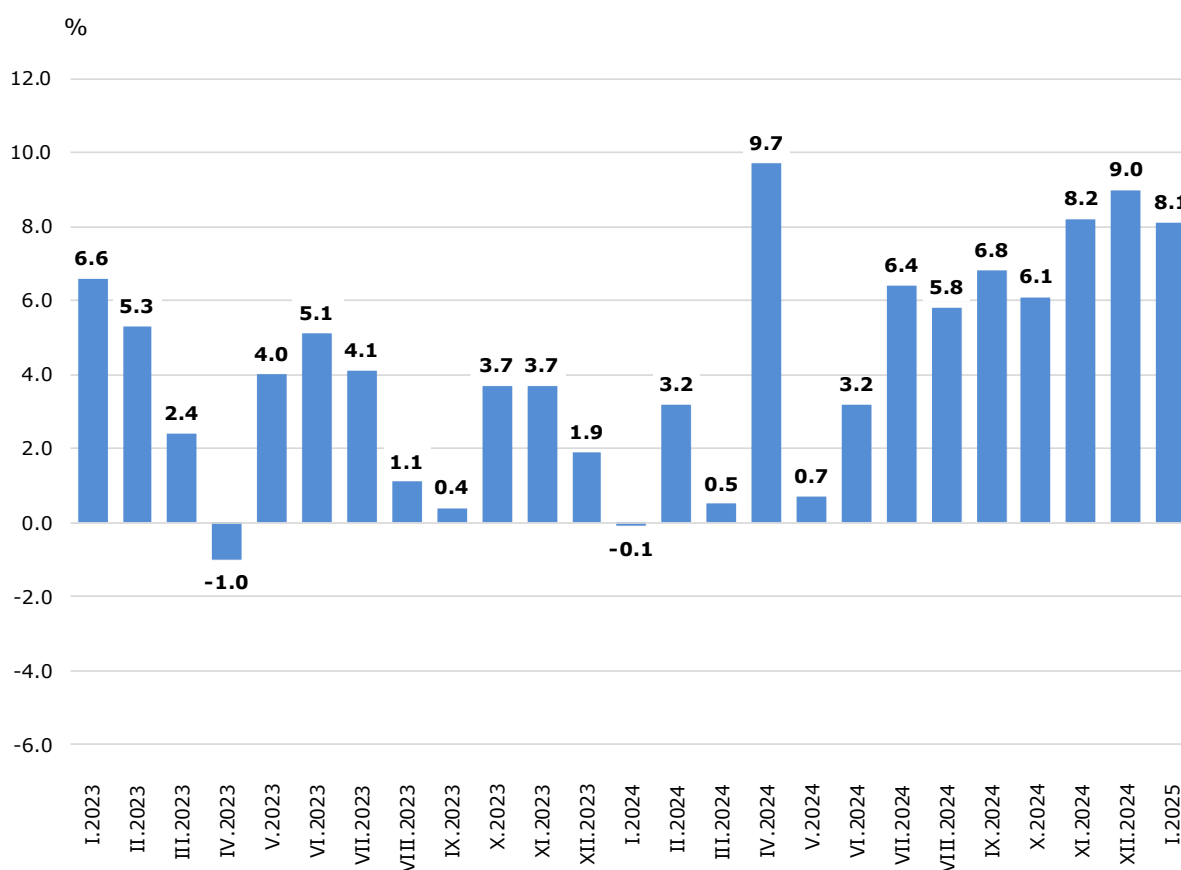
## TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT MOTOR VEHICLES AND MOTORCYCLES', JANUARY 2025

### Annual changes

In January 2025, compared to the same month of 2024, an increase of the turnover was registered in all of the big groups: 'Retail sales of automotive fuel in specialised stores' - by 15.5%, 'Retail sales of non-food products (except fuel)' - by 9.8%, and in 'Retail sales of food, beverages and tobacco' - by 3.9%.

In the group 'Retail sales of non-food products (except fuel)', a growth was observed in all subgroups. A major rise was registered in 'Retail sales of textiles, clothing, and footwear and leather goods' - by 19.7%.

### **Methodological notes**

The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices, trade enterprises are observed by using a representative sample that forms about 70% of the annual receipts of the observed aggregate. The monthly turnover indices are calculated according to Regulation (EU) 2019/2152 of the European Parliament and of the Council on European Business Statistics repealing 10 legal acts with 2021 as a base year.

Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.

Calendar adjustment is an adjustment for variations caused by calendar effects, a different number of calendar and working days in the months, national holidays and outliers (for example, the presence of more non-working days in May could contribute to the decline in the retail trade).

Since July 2024, all dynamic rows have been recalculated based on 2021 base year and have been published in IS Infostat.
