



1. Total Producer Price Indices in Industry


The Total Producer Price Index in Industry fell by 0.5% in March 2025 compared to the previous month. A decrease of 1.6% was registered in the electricity, gas, steam and air conditioning supply, and in the manufacturing industry - by 0.5%. An increase was observed in the mining and quarrying industry - by 7.6%.

Lower prices in the manufacturing industry were registered in the manufacture of basic metals - by 1.8%, in the manufacture of electrical equipment - by 0.3%, in the manufacture of wearing apparel - by 0.2%. An increase was seen in the manufacture of beverages - by 1.4%, in the manufacture of other transport equipment - by 1.1%, in the manufacture of other non-metallic mineral products - by 0.8%.

The Total Producer Price Index went up by 17.4% in March 2025 compared to the same month in 2024. An increase was observed in the electricity, gas, steam and air conditioning supply - by 53.1%, in the mining and quarrying industry - by 32.4%, as well as in the manufacturing industry - by 10.7%.

In the manufacturing, prices rose in the manufacture of basic metals - by 29.8%, in the manufacture of food products - by 24.4%, in the manufacture of beverages - by 15.5%. Price reduction was registered in the manufacture of tobacco products - by 12.4%, and in the manufacture of furniture - by 6.8%.

2. Producer Price Indices on Domestic Market


The Producer Price Index on the Domestic Market decreased by 1.0% in March 2025 compared to February 2025. The domestic prices fell in the electricity, gas, steam and air conditioning supply - by 2.6%, and in the manufacturing industry - by 0.3%, while in the mining and quarrying industry was reported an increase by 7.1%.

In the manufacturing, compared to the previous month, lower prices were registered in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 0.7%, in the manufacture of chemicals and chemical products, and in the manufacture of fabricated metal products, except machinery and equipment - all by 0.4%. The prices went up in the manufacture of beverages and in the manufacture of other non-metallic mineral products - both by 1.5%, in the manufacture of basic pharmaceutical products and pharmaceutical preparations - by 1.3%.

The Producer Price Index on the Domestic Market grew by 22.0% compared to March 2024. The prices rose in the electricity, gas, steam and air conditioning supply - by 59.9%, in the mining and quarrying industry - by 26.9%, and in the manufacturing industry by 11.3%.

In March 2025, higher prices in the manufacturing in comparison with March 2024 were seen in the manufacture of food products - by 30.9%, in the manufacture of basic metals - by 22.5%, in the manufacture of beverages - by 20.8%. Lower prices were reported in the manufacture of motor vehicles, trailers and semi-trailers - by 6.2%, in the other manufacturing - by 6.1%, in the manufacture of leather and related products - by 3.9%.

3. Producer Price Indices on Non-domestic Market

The Producer Price Index on the Non-domestic Market rose in March 2025 compared to the previous month by 0.1%, and by 10.7% in comparison with March 2024.

Methodological notes

Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered an early measure of the current inflation process in the economy and they can be used for international comparisons. Information for the calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of the total industrial production.

Total Producer Price Indices are calculated from Producer Price Indices on the Domestic Market and Producer Price Indices on the Non-domestic Market, weighted with the turnover structure on the domestic and the non-domestic market to the total value of turnover in the base year (2021).

Producer Price Indices on the Domestic Market are calculated at a constant base (2021), weighed with the turnover structure on the domestic market.

Producer Price Indices on the Non-domestic Market are calculated at a constant base (2021), weighed with the turnover structure on the non-domestic market.
