


## EMPLOYEES UNDER LABOUR CONTRACT AND AVERAGE WAGES AND SALARIES, FIRST QUARTER OF 2010

According to the preliminary data of the National Statistical Institute (NSI) the number of employees under labour contract at the end of March 2010 decreased by 64 th. or 2.8% as compared to the end of December 2009 and reached 2.19 millions. The highest decrease was reported in economic activities "Accommodation and food service activities" - 9.4%, "Construction" - 7.4% and "Professional, scientific and technical activities" - 6.2%.

In the structure of employees by economic activities the biggest relative share of employees was in "Manufacturing" - 23.2% and "Wholesale and retail trade; repair of motor vehicles and motorcycles" - 18.4%, where the number of employees at the end of March 2010 compared to December 2009 decreased by 2.5 and 5.4% respectively.

At the end of March 2010 as compared to March 2009 the number of employees under labour contract was declined by 222 th. or 9.2%. The highest decrease in absolute figures was observed in economic activities "Manufacturing" - 65 th., "Construction"- 51 th. and "Wholesale and retail trade; repair of motor vehicles and motorcycles" - 36 thousands. In percentages the highest decrease was in "Construction" - 25.5% and "Accommodation and food service activities"" - 17.3%.

The average monthly wages and salaries of the employees under labour contract in March 2010 increased by 11 levs in nominal terms compared to December 2009.




In the first quarter of 2010 in comparison with the fourth quarter of 2009 the average monthly wages and salaries increased by 2.1% getting 619 levs. The highest increase in wages and salaries was reported in "Information and communication" - 22.9%, "Professional, scientific and technical activities" - 13.2% and "Other service activities" - 9.1%. The highest decreases in average monthly wages and salaries in first quarter of 2010 as compared to fourth



quarter of 2009 where observed in economic activities: "Arts, entertainment and recreation" - 6.8%, "Education" - 5.7% and "Construction" - 4.5%.

Compared to the first quarter of 2009 the average monthly wages and salaries in the first quarter of 2010 rose by 9.9%. The highest growth rates were recorded in economic activities:



"Information and communication" - 29.1% and "Other service activities" - 21.2%. The economic activities with the highest wages and salaries in the first quarter of 2010 were:


- ➤ "Electricity, gas, steam and air conditioning supply" 1 327 levs
- ➤ "Financial and insurance activities" 1 302 levs
- "Information and communication" 1 208 levs

The lowest wages and salaries were recorded in:

- ➤ "Accommodation and food service activities" 415 levs
- ➤ "Administrative and support service activities" 427 levs
- "Agriculture, forestry and fishing" 445 levs.

In comparison with a year earlier the average monthly wages and salaries in public sector grew by 6.1%, while in private sector - by 11.5%.

#### **Methodological notes**

The source of information is the Quarterly Survey on employees, hours worked, wages and salaries, and other expenditures paid by the employer. It is sample survey which main purpose is to make a study of the current state and dynamics of some main aspects of labour market. The sample used for the survey is a stratified random sample without replacement. Stratification criteria used include: economic activity (NACE rev.2), size of the enterprise (according to the number of employees) and regional breakdown (28 districts, NUTS3).
