





TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN OCTOBER 2010

In October 2010, the number of the trips of Bulgarian residents abroad was 291.7 thousand, or 19.4% less than the number of the trips in October 2009 (Table 1). A decrease in the number of the trips to all surveyed countries was observed. The highest decline was registered in the trips to Malta - by 84.3%, Portugal - by 78.2%, Switzerland - by 76.6%, Italy - by 69.6%, Belgium - by 67.8%, Slovakia - by 66.3%, France - by 66.0%, United Kingdom - by 65.9%, Poland - by 65.5% Spain - by 64.8%, Russian Fed. - by 64.5% and Cyprus - by 64.0%.

The highest share of the trips of Bulgarian citizens travelling abroad had the trips with professional purpose - 55.6%, followed up by visits as guests - 22.9%, holiday and recreation - 18.0%, and others - 3.5%.

Figure 1. Structure of the trips of Bulgarian residents abroad by purpose of visit in October 2010




In October 2010, the number of arrivals of visitors from abroad to Bulgaria was 477.2 thousand or 5.1% more than the number of trips in the corresponding month of 2009 (Table 2). An increase in the number of visitors with purpose holiday and recreation by 5.0% was registered. The visits as guests and visitors passing transit were increased by 10.3% and 13.7% respectively. At the same time, a decrease was recorded in visits with professional purpose by 0.5% and visits with other purposes - by 4.2%.

Figure 2. Number of arrivals of visitors to Bulgaria from abroad by purpose of visit




The arrivals of visitors from EU Member States rose by 1.2%, while the highest growth was observed in the number of visits from Hungary and Slovenia - 51.7% and 36.7% respectively. A decrease was registered in the visits from Malta - by 42.6%, Finland - by 36.9%, Ireland - by 27.6%, etc.

The visits of foreigners in the group "Other European countries" were increased by 16.7%. The largest growth was observed in the number of arrivals of citizens from Serbia - by 66.0%, Russian Fed. - by 40.2% and FYROM - by 36.8%.

In September 2010, arrivals with purpose holiday and recreation composed the greatest share of the total number of foreigners visited to Bulgaria - 36.0%, followed by transit trips - 29.2%, professional purpose - 18.0%, others - 14.0% and visits as guests - 2.8%.

Methodological notes

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
