



TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN OCTOBER 2012




Figure 1. Trips of Bulgarian residents abroad by months

In October 2012 the number of the trips of Bulgarian residents abroad was 281.5 thousand or by 15.7% less than in September 2012 and by 4.9% under the registered in October 2011 (Figure 1). In comparison with the same month of the previous year a decrease in the total number of the trips of Bulgarian residents was reported to: Serbia - by 29.3%, Turkey - by 28.0%, FYROM - 26.4% and Romania - by 19.3%. At the same time an increase was observed to: Austria - by 108.6%, the United Kingdom - by 103.9%, Italy - by 97.3%, Spain - by 56.9% and etc. (Annex, Table 1).


The trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 47.2%, followed by the trips with holiday and recreation purposes - 29.3% and with professional purpose - 23.5%. In comparison with October 2011 an increase was observed in the trips with holiday and recreation purpose, as well as these with other purposes - by 46.6 and 73.1% respectively, while a decrease in the trips with professional purposes was registered - by 59.3%.

In October 2012 the trips with other purposes formed 63.9% from all trips to the United Kingdom, 58.3% - to Germany, 53.7% - to Greece. Predominated share of the trips to Spain and Turkey was with holiday and recreation purpose - 52.6 and 42.1% respectively, while to Belgium and France they were connected with professional purpose - 66.7 and 50.0% respectively of all trips of Bulgarian residents to these countries (Figure 2).




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In October 2012, **the number of arrivals of visitors from abroad to Bulgaria** was 524.0 thousand which was by 51.6% less compared to September 2012 and by 3.0% above the level from October 2011 (Figure 3). An increase in the visit with holiday and recreation purpose - by 7.3% and with professional purpose - by 3.8% was registered, while the visit with other purposes decreased by 1.0%.

The visits of the citizens of European Union composed the greatest relative share of the total number of foreigners visited Bulgaria - 56.5%, followed by these from the other European countries - 34.7% (Annex, Table 2). In comparison with the same month of the previous year the arrivals of visitors from EU Member States increased by 0.4%. A significant increase was observed in the visits of the citizens from France - by 9.0%, Greece - by 8.1%, Austria - by 6.4% and the United Kingdom - by 6.0%. However a drop in the visits from Romania - by 5.9% and Italy - by 3.3% was registered.

The visits of foreigners in the group "Other European countries" increased by 8.5% as the highest growth was observed in the visits of citizens of Russian Federation and Turkey - by 41.8 and 19.5% respectively.

In October 2012 the predominated share of the total number of the visits to Bulgaria were with other purposes (including as guest and passing transit) - 42.4% followed by the arrivals with holiday and recreation purpose - 39.3% and with professional purpose - 18.3%.

The visits with holiday and recreation purpose formed 80.0% of the arrivals from FYROM, 70.4% - from United Kingdom, 60.4% - from Serbia and 53.0% - from Russia. The visits with professional purpose were 64.0% of all arrivals from Spain and 59.8% - from Austria, while with other purpose were 76.0% of the arrivals from Turkey, 64.6% - from Ukraine and 49.5% - from Greece (Figure 4).



Methodological notes

The definitions recommended by the World Tourist Organization and Methodological manual for tourism by Eurostat are applied by National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence at least 24 hours but no more than one year and whose main purpose is not doing any activity for payment.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical sightseeing, sports events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, cure, etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
