



## PRODUCER PRICE INDICES IN INDUSTRY<sup>1</sup>, **FEBRUARY 2015**

## **Producer Price Indices on Domestic Market<sup>2</sup>** 1.

Producer Price Index on Domestic Market in February 2015 increased by 0.7% compared to the previous month. The domestic prices rose in the manufacturing by 1.1%, in the mining and quarrying industry by 0.7%, and in the electricity, gas, steam and air conditioning supply the prices by 0.1%.

In the manufacturing<sup>3</sup>, compared to the previous month the prices went up in the manufacture of chemicals and chemical products by 1.9% and in the manufacture of textiles by 0.5%, while a price decrease was reported in the in the repair and installation of machinery and equipment by 1.3% and in the printing and reproduction of recorded media by 0.4%.

**Producer Price Index on Domestic Market** in February 2015 decreased by 1.2% compared to the same month of 2014. The domestic prices fell in the manufacturing by 4.2% and in the mining and quarrying industry by 3.1%, while prices increases were registered in the electricity, gas, steam and air conditioning supply by 4.2%.

In the manufacturing compared to February 2014, a price decrease was reported in the manufacture of basic metals by 1.6%, in the printing and reproduction of recorded media by 1.5%, in the manufacture of food products by 1.4%. The prices increases were seen in the manufacture of beverages and in the manufacture of chemicals and chemical products by 2.1%, in the manufacturing of computer, electronic and optical products by 2.0%.

<sup>&</sup>lt;sup>1</sup>Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on nondomestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

<sup>&</sup>lt;sup>2</sup> Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

## 2. Total Producer Price Indices in Industry<sup>1</sup>

**Total Producer Price Index in Industry** in February 2015 increased by 1.4% compared to the previous month. Higher prices were registered in the manufacturing by 1.9%, in the mining and quarrying industry by 1.6%, and in the electricity, gas, steam and air conditioning supply by 0.1%.

In the manufacturing<sup>2</sup>, more significant prices increases were seen in the manufacture of textiles by 4.1%, in the manufacture of chemicals and chemical products by 2.3%, and in the manufacture of basic metals by 1.3%, while prices decreases were reported in the repair and installation of machinery and equipment by 1.1%, in the manufacture of leather and related products by 0.8%, and in the manufacture of rubber and plastic products by 0.5%.

<sup>1</sup> Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Nondomestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year.

**Total Producer Price Index** in February 2015 decreased by 1.4% compared to the same month of 2014.

In the manufacturing, the prices fell by 3.3% compared to February 2014. More significant prices decreases were seen in the manufacture of food products by 1.4% and in the printing and reproduction of recorded media by 1.0%, while the producer prices went up in the manufacture of other transport equipment by 9.2%, in the manufacture of textiles by 5.2% and in the manufacture of wearing apparel by 5.0%.
