




## BULGARIAN TRADE WITH EU IN JANUARY 2015 (PRELIMINARY DATA)

In **January 2015** Bulgarian **exports to the EU** increased by 16.7% compared to the same month of 2014 and amounted to 2.3 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Italy, Greece, Romania, France and Belgium which accounted for 70.0% of the exports to the EU Member States (Annex, Table 3).

(Compared to the same month of the previous year)**




Bulgarian **imports from the EU** in January 2015 increased insignificantly compared to the same month of 2014 and added up to 2.3 Billion BGN at CIF prices (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Spain, Romania, Italy and Greece (Annex, Table 3).

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with the EU** in January 2015 was negative and added up to 33.1 Million BGN (Annex, Table 1). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the trade balance was positive and amounted to 64.9 Million BGN.

In **January 2015** compared to the same month of 2014 the largest growth **in the exports** of Bulgaria to the **EU** distributed according to the Standard International Trade Classification (Annex, Table 4) was recorded in the sections “Mineral fuel, lubricants and related materials” (125.0%) and “Crude materials, inedible (except fuel)”<sup>2</sup> (36.4%). The most notable fall was recorded in section “Beverages and tobacco” (17.0%).

In **imports from the EU** the largest growths were reported in the sections “Beverages and tobacco” (22.1%) and “Manufactured goods classified chiefly by material” (21.2%) while the most notable fall was observed in section “Mineral fuel, lubricants and related materials” (53.9%).
