



# ACTIVITY OF FINANCIAL ENTERPRISES AND ASSOCIATIONS AND FOUNDATIONS IN 2014 (PRELIMINARY DATA)

#### 1. Insurers

At the National Statistical Institute 57 licensed insurers submitted annual reports for 2014, with balance value of assets at the end of the year of 3 872 million BGN and realised turnover<sup>1</sup> at current prices of 1 917 million BGN.




Figure 1. Balance value of assets and turnover of insurers by years

In 2014 the insurers reported a positive financial result of their activity in the amount of 45 million BGN. In life assurance was realised a profit of 33 million BGN and in non-life assurance - 12 million BGN.




Figure 2. Financial result of insurers by years

### 2. Pension Companies and Pension Funds

In 2014 a total of 9 pension companies developed their activity in Bulgaria, with balance value of assets as of 31.12.2014 for 258 million BGN.

The turnover<sup>1</sup> of pension companies for 2014 at current prices reached 124 million BGN and the realised profit amounted to 41 million BGN.

Annual reports for their activity in 2014 at the NSI were submitted by 28 pension funds. 18 of them were compulsory pension funds (9 universal and 9 professional funds) and 10 were voluntary pension funds. The balance value of their assets as of 31.12.2014 was 8 185 million BGN and the investments reached 7 818 million BGN.

The total number of insured persons in pension funds as of 31.12.2014 was 4 291 007 and the gross receipts from contributions amounted to 1 046 million BGN.




Figure 3. Structure of investments of pension funds by years

### 3. Special Investment Purpose Companies

Annual reports for their activity in 2014 were submitted at the NSI by 246 special investment purpose companies (investment companies, investment intermediaries, managing investment companies, investment funds and companies limited by shares with special purpose). The balance value of their assets as of 31.12.2014 was 7 373 million BGN and foreign assets received (securities and cash to customers) amounted to 4 848 million BGN.

The financial revenues (turnover) of special purpose insurance companies for 2014 at current prices totalled 659 million BGN and the financial result for the year was a profit of 32 million BGN.

#### 4. Associations and Foundations

The number of associations and foundations, which submitted annual reports for 2014 at the NSI, was 9 512 and according to preliminary data the balance value of their assets as of 31.12.2014 amounted to 931 million BGN.

The total revenues from non-regular activities for 2014 at current prices were 546 million BGN and their revenues from regular activity reached 514 million BGN.



The members of associations and foundations as of 31.12.2014 were 2 004 172, of which 113 454 were legal entities and 1 890 718 were individuals. The volunteers which worked in them were 72 393, as they worked a total of 1 547 527 hours.
