



## ACTIVITY OF NON-FINANCIAL ENTERPRISES<sup>1</sup> FOR 2016 (PRELIMINARY DATA)

### 1. Overview

According to preliminary data 335 802 non-financial enterprises submitted their annual reports for 2016 at the National Statistical Institute. They generated 137 139 million BGN of production value and 48 566 million BGN of value added at factor cost, and employed 1 966 554 persons.

## 2. Industry

According to preliminary data 34 178 industrial enterprises submitted annual reports on their activities in 2016, which were 10.2% of the total number of the reported non-financial enterprises at the NSI.

In 2016 the production value of industrial enterprises was 66 376 million BGN at current prices, or 48.4% of the total value of non-financial enterprises. The changes in the structure by sectors were insignificant compared to 2015. The share of the 'Manufacturing' sector increased by 0.5 percentage points and reached 82.5% of the industrial production value at the expense of the decrease by 0.4 percentage points (to 11.5%) in the 'Electricity, gas, steam and air conditioning supply' sector



and in the 'Mining and quarrying' sector - by 0.1 percentage points to 3.8%. The share of the 'Water supply; sewerage, waste management and remediation activities' sector remained unchanged - 2.2%.

According to preliminary data, in 2016 the value added at factor cost in the Industry amounted to 19 271 million BGN at current prices, which formed 39.7% of the total value of non-financial enterprises.

In 2016 the number of persons employed in the industrial enterprises was 639 168 persons, or 32.5% of the total employment in non-financial enterprises.

### **3.** Construction

Annual reports on their activities in 2016 according to preliminary data were submitted at the NSI by 19 513 construction enterprises, or 5.8% of the total number of reported non-financial enterprises.

In 2016 the production value in construction sector was 11 548 million BGN at current prices, or 8.4% of the total value of non-financial enterprises. The structure of the production value in the



construction sector changed significantly - the share of 'Construction of buildings' increased by 9.4 percentage points to 38.6%, as well as the share of 'Specialised construction activities' - by 5.3 percentage points. At the same time, the share of the 'Civil engineering' division decreased to 36.8%.

In 2016 in the construction sector the value added at factor cost amounted to 2 697 million BGN at current prices, or 5.6% of the total value of non-financial enterprises.

The number of persons employed in the construction sector in 2016 was 142 570 and formed 7.3% of the total employment in non-financial enterprises.





### 4. Wholesale and retail trade; repair of motor vehicles and motorcycles

Annual reports on their activities in 2016, according to preliminary data, were submitted at the NSI by 140 425 trade enterprises, or 41.8% of the total number of reported non-financial enterprises.

In 2016 the production value in the trade sector was 20 946 million BGN at current prices, which formed 15.3% of the total production value of non-financial enterprises.

In the trade sector, according to preliminary data, the value added at factor cost amounted to 10 359 million BGN at current prices, or 21.3% of the total value of non-financial enterprises. Compared to the previous year in the structure of value added the share of 'Retail trade, except of motor vehicles and motorcycles' increased by 1.9 percentage points reaching to 34.2%. The share of 'Wholesale trade, except of motor vehicles and motorcycles' decreased by 2.1 percentage points to 57.0% and the share of 'Wholesale and retail trade and repair of motor vehicles and motorcycles' increased by 0.2 percentage points.

In 2016 in the trade sector were employed 511 690 persons that formed 26.0% of the total employment in non-financial enterprises.

#### **5.** Services

Annual reports on their activity in 2016, according to preliminary data, were submitted by 141 686 enterprises in the service sector, or 42.2% of the total number of the reported non-financial enterprises at the NSI.

In 2016 production value at current prices for 38 269 million BGN was generated by service sector which formed 27.9% of the total production value of non-financial enterprises. Compared to 2015 the structure of value added by sectors was changed - the share of sector 'Professional scientific and technical activities' decreased by 1.9 percentage points to 16.2%, while the share of sector 'Information and communication' increased by 0.6 percentage points and reached 21.9%. The share of all other activities varied slightly or remained the level of the previous year.

According to preliminary data, in 2016 the value added at factor cost in the service sector was 16 239 million BGN at current prices, or 33.4% of the total value of non-financial enterprises.

In 2016, according to preliminary data, the number of persons employed in the service sector reached 673 126 and formed 34.2% of the total employment in non-financial enterprises.







#### Methodological notes

**Coverage -** in compliance with the Regulation (EC) 295/2008 on SBS the non-financial enterprises include all sections by NACE Rev. 2, with the exception of 'Agriculture, forestry and fishing', 'Financial and insurance activities', 'Public administration, education, human health and social work activities', 'Activities of membership organisations' and 'Activities of households'.

**Number of enterprises** - includes all non-financial enterprises, which were active during whole or part of the reference year (have realised revenue from sales or have had at least one person employed) and have submitted their annual reports in the National statistical Institute and/or National Revenue Agency.

**Turnover** includes the value of all revenue from sales of own products, goods bought and sold in the same condition, services provided and row materials sold, including accrued excise duties, which are invoiced during the reference period. It does not include the revenue from sales of fixed assets, the income from financing, the financial and the extraordinary revenue. The value of turnover does not include accrued taxes on the type of value added tax (VAT) which are charged to the end user.

**The production value** includes the value of turnover, reduced by the balance sheet of assets sold without own fixed assets. The changes in stocks of products and work in progress, as well as the costs incurred to acquire the assets by economic means are also included.

Value added at factor cost includes the production value, reduced by the amount of the excise duties and operating expenses, excluding those for the personnel and for depreciation, and increased by the income from financing.

**Number of persons employed** includes all persons employed working in a given enterprise on full or part-time, including seasonal workers, home workers, working owners, employees under contract for management and control, employees in civil contracts that do not work with another employer and unpaid family workers. It does not include those absent for an unlimited time, as well as those provided under contract by other companies.
