

### PRODUCTION AND DELIVERIES OF ENERGY PRODUCTS, SEPTEMBER 2022

In September 2022, compared to the previous month, for the production of energy products, an increase was observed only in solid fuels - by 17.4%, and the largest decrease was registered in unleaded motor gasoline - by 37.9%.

In September 2022, compared to the previous month, for the deliveries of energy products, the largest increase was observed in solid fuels - by 17.1%, and the largest decrease was registered in transport diesel - by 17.4%.

## **Production of energy products**

In September 2022, compared to August 2022, an increase is reported for the production of:

- solid fuels by 17.4% to 2 883 thousand tonnes.
- A decrease is reported for the production of:
- unleaded motor gasoline by 37.9% to 100 thousand tonnes;
- liquefied petroleum gases by 27.3% to 8 thousand tonnes;
- transport diesel by 14.5% to 278 thousand tonnes;
- electricity by 10.1% to 3 708 GWh.

No change for the production of natural gas (Annex, Table 1).

In September 2022, compared to the same month of the previous year, an increase is reported for the production of:

- transport diesel by 31.8%;
- solid fuels by 1.3%.
- A decrease is reported for the production of:
- natural gas by 50.0%;
- liquefied petroleum gases by 11.1%;
- electricity by 7.5%;
- unleaded motor gasoline by 6.5%.

## **Deliveries of energy products**

In September 2022, compared to August 2022, an increase is reported for the deliveries of:

- solid fuels by 17.1% to 2 863 thousand tonnes;
- unleaded motor gasoline by 13.0% to 52 thousand tonnes;
- natural gas by 2.2% to 139 million m<sup>3</sup>.
- A decrease is reported for the deliveries of:
- transport diesel by 17.4% to 200 thousand tonnes;
- electricity by 9.2% to 2 336 GWh;
- liquefied petroleum gases by 6.7% to 42 thousand tonnes (Annex, Table 2).

In September 2022, compared to the same month of the previous year, an increase is reported for the deliveries of:

- liquefied petroleum gases by 20.0%;
- unleaded motor gasoline by 13.0%.
- A decrease is reported for the deliveries of:
- natural gas by 32.5%;
- transport diesel by 8.7%;
- electricity by 2.5%;
- solid fuels by 1.7%.



#### **Methodological notes**

The survey on energy products is conducted every month in accordance with Regulation (EO) No. 1099/2008 of the European Parliament and of the Council of 22 October 2008 on energy statistics and its amendments. The survey aims to submit information on the production and inland deliveries of the main energy products - electricity, solid fuels, natural gas and petroleum products. The reporting units are producers, importers and exporters of energy products. Production and deliveries of the energy products are the main observed indicators.

#### Solid fuels

*Production* - includes Hard coal, Lignite and Solid fuels from coal. Producers report quantities calculated after any operation for the removal of inert matter.

*Deliveries* - quantities delivered to the internal market. They are equal to the total of the deliveries to the different types of consumers: producers' own use, main activity power stations, coking plants and patent fuel plants, industry, iron and steel industry and others.

Since 1.01.2017 Brown coal briquettes have been excluded from the monthly survey.

#### **Petroleum products**

Production - includes production of finished products at a refinery or blending plant.

*Deliveries* - wholesale deliveries to the domestic market of finished petroleum products from producers and importers/exporters.

Deliveries of petroleum products are defined as: primary product receipts + gross refinery output + recycled products - refinery fuel + imports - exports - international marine bunkers + interproduct transfers - products transferred - stock changes.

#### Natural gas

*Production* - includes all dry marketable production within national boundaries, including offshore production. Production is measured after purification and extraction of NGLs and sulfur. Excludes extraction losses and quantities reinjected, vented or flared. Includes quantities used within the natural gas industry; in gas extraction, pipeline systems and processing plants.

Deliveries - total natural gas, distributed for the internal market, including own use and losses.

Data are presented in million cubic meters assuming reference gas conditions  $15^{\circ}$ C and 101.325 kPa. To convert quantities from cubic meters at  $20^{\circ}$ C to cubic meters at  $15^{\circ}$ C - according to the reporting requirements of Regulation (EC) No. 1099/2008 of the European Parliament and the Council on energy statistics, we use a conversion factor of 0.98294.

## Electricity

*Production* - includes produced electricity from Thermal power plants, Nuclear power plants, Hydropower plants, Pumped storage plants and electricity, obtained from wind generators and solar panels.

*Deliveries /Total net consumption* - the sum of the net produced electricity and net import, reduced by the amount used for pumped storage.
