BULGARIAN TRADE WITH THIRD COUNTRIES IN 2011 (PRELIMINARY DATA)

In 2011 the Bulgarian exports to third countries increased by 24.4% compared to 2010 and exceeded 14.8 billion levs (Table 1.1 and 1.2). The main trade partners of Bulgaria were Turkey, Russia, Serbia, The former Yugoslav Republic of Macedonia, China, Ukraine and USA that formed 52.9% of the total exports to non EU countries (Table 2). The exports to South Africa, Canada, Egypt and China increased significantly. The most significant falls were reported on the exports to Singapore, Syria, Peru and Viet-Nam.

In December 2011 the exports to third countries increased by 5.4% compared to the corresponding month of the previous year and exceeded 1.2 billion levs.





Figure 1. Nominal growth of exports to non EU countries for the period 2009 - 2011 (Compared to the same month of the previous year)

Bulgarian **imports from third** countries **in 2011 increased by 19.2%** compared to 2010 and **amounted to 18.6 billion levs (at CIF prices)** (Tables 1.1 and 1.2). The most significant growths were reported on the imports from Kazakhstan, Israel, Singapore and South Africa (Table 2). The largest decreases were observed in the imports from Peru, Iran and Viet-Nam.

In December 2011 the Bulgarian imports from third countries decreased by 3.6% compared to the corresponding month of the previous year and reached 1.5 billion levs.





The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in 2011 was negative and reached 3807.7 million levs (Table 1.1). The trade balance at FOB /FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 2830.9 million levs.

In **December 2011** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and reached 256.1 million levs.

The exports of Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, increased in all sections in 2011 compared to 2010 (Table 3). The largest growths were recorded in the sections: "Crude materials, inedible (except fuel)"¹, "Animal and vegetable oils, fats and waxes"² and "Mineral fuels, lubricants and related materials".

The largest growths in imports from third countries were reported in section "Chemical and related products", "Manufactured goods classified chiefly by material"³ and "Mineral fuels, lubricants and related materials". Falls were reported in sections "Crude materials, inedible (except fuel)" and "Animal and vegetable oils, fats and waxes".



Bulgarian trade with third countries and EU - total


In **2011 the total value of the exported goods amounted to 39.3 billion levs.** Compared to 2010 the exports **increased by 29.2%** (Table 1.1 and 1.2).

In December 2011 **the total exports amounted to 3.1 billion levs** and increased by 13.5% compared to the corresponding month of the previous year.



The total value of all imported goods in 2011 was 45.1 billion levs (at CIF prices), or by 19.9% more than 2010 (Table 1.1 and 1.2).

In December 2011 **the total imports increased by 7.9%** compared to the corresponding month of the previous year and reached 3.9 billion levs.



ATISTICAL INSTITUTE

The total foreign trade balance (exports FOB - import CIF) was negative in 2011 and amounted to 5813.8 million levs which was 1390.7 million levs less than the balance in 2010 (Table 1.1 and 1.2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the balance was also negative and amounted to 3605.7 million levs.

In December 2011 the total foreign trade balance (**exports FOB** - **import CIF**) was negative and amounted to 822.1 million levs. The trade balance at FOB/FOB prices was also negative and reached 625.4 million levs.
