




## BULGARIAN TRADE WITH THIRD COUNTRIES IN THE PERIOD JANUARY - APRIL 2015 (PRELIMINARY DATA)

In the period **January - April 2015** Bulgarian **exports to third countries** increased by 13.8% compared to the corresponding period of 2014 and amounted to 5.4 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, Singapore, USA and Russian Federation which accounted for 51.0% of the exports to non EU countries (Annex, Table 3).

In April 2015 exports to third countries increased by 12.8% compared to the corresponding month of the previous year and amounted to 1.5 Billion BGN.

**Bulgarian imports from third countries in the first four months of 2015** increased by 1.3% compared to the corresponding period of 2014 and added up to 6.2 Billion BGN (at CIF prices) (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

**In April 2015** Bulgarian imports from third countries decreased by 0.8% compared to the corresponding month of the previous year and amounted to 1.7 Billion BGN.



**The foreign trade balance** of Bulgaria (export FOB - import CIF) **with third countries** in the period January - April 2015 was negative and added up to 799.2 Million BGN (Annex, Table 1). The trade balance at FOB/FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 518.2 Million BGN.

**In April 2015** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and amounted to 157.9 Million BGN.

In the first four months of 2015 compared to the corresponding period of 2014 in the exports of Bulgaria to third countries distributed according to the **Standard International Trade Classification** the largest growth were recorded in the section 'Animals and vegetable oils, fats and waxes' (279.1%) and 'Miscellaneous manufactured articles' (52.0%) (Annex, Table 4). Fall was reported in section 'Beverages and tobacco' (0.6%).

In imports from third countries the largest growths were reported in sections 'Food and live animals' (32.7%) and 'Crude materials, inedible (except fuels)' (28.6%) while the most notable fall was observed in section 'Beverages and tobacco' (28.0%).

## Bulgarian trade with third countries and EU - total

In the period January - April 2015 the value of all exported goods from Bulgaria amounted to 14.6 Billion BGN and compared to the corresponding period of 2014 the exports increased by 12.8% (Annex, Table 1 and 2).

In April 2015 the total exports added up to 3.9 Billion BGN and increased by 12.8% compared to the corresponding month of the previous year.




Figure 3. Nominal value<sup>1</sup> change of exports of Bulgaria in the period 2014 - 2015 (Compared to the same month of the previous year)

The total value of **all the goods imported in** the country **in the period January - April 2015** amounted to 16.8 Billion BGN (at CIF prices), or by 5.2 % more than the corresponding period of 2014 (Annex, Table 1 and 2).

In April 2015 the total imports increased by 4.9% compared to the corresponding month of the previous year and added up to 4.5 Billion BGN



The **total foreign trade balance** (exports FOB - import CIF) was negative in the period January - April 2015 and amounted to 2 201.6 Million BGN which was 830.8 Million BGN less than the balance in the first four months of 2014 (Annex, Table 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January - April 2015 the total foreign trade balance was also negative and amounted to 1 460.2 Million BGN.

In April 2015 the total foreign trade balance (exports FOB - import CIF) was negative and added up to 621.5 Million BGN. The trade balance at FOB/FOB prices was also negative and amounted to 401.9 Million BGN
