




BULGARIAN TRADE WITH THIRD COUNTRIES IN THE PERIOD JANUARY - APRIL 2016 (PRELIMINARY DATA)

In the period **January - April 2016** Bulgarian **exports to third countries** decreased by 13.8% in comparison with the same period of 2015 and amounted to 4 632.0 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Turkey, China, the Former Yugoslav Republic of Macedonia, Serbia, USA and Russian Federation, which accounted for 50.1% of the exports to non-EU countries (Annex, Table 3).

In April 2016 Bulgarian **exports to third countries** dropped by 26.8% compared to the corresponding month of the previous year and added up to 1 098.8 Million BGN.

In the first four months of 2016 compared to the same period of 2015 in the exports of Bulgaria to third countries distributed according to the **Standard International Trade Classification** growths were recorded in the sections 'Miscellaneous manufactured articles' (49.0%) and 'Machinery and transport equipment' (2.1%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (38.5%).




Bulgarian imports from third countries in the period **January - April 2016** decreased by 19.4% in comparison with the same period of 2015 and added up to 4 961.6 Million BGN (at CIF prices) (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

In April 2016 Bulgarian imports from third countries dropped by 20.2% compared to the corresponding month of the previous year and amounted to 1 323.5 Million BGN.

In the first four months of 2016 compared to the corresponding period of 2015 in the imports of Bulgaria from third countries distributed according to the **Standard International Trade Classification** the largest growths were recorded in the sections 'Animals and vegetable oils, fats and waxes' (16.4%) and 'Miscellaneous manufactured articles' (16.3%) while the most notable fall was observed in section 'Crude materials, inedible (except fuel)' (45.0%).

The foreign trade balance of Bulgaria (export FOB - import CIF) **with third countries** in the period **January - April 2016** was negative and added up to 329.6 Million BGN (Annex, Table 1). The trade balance at FOB/FOB prices (after elimination of transport and insurance costs on imports) was positive and amounted to 1.9 Million BGN.

In April 2016 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and added up to 224.7 Million BGN.

Bulgarian trade with third countries and EU - total

In the period **January - April 2016** the value of **all exported goods** from Bulgaria amounted to 14 226.1 Million BGN and in comparison with the corresponding period of 2015 the exports decreased by 3.0% (Annex, Table 1 and 2).

In **April 2016 the total exports** added up to 3 633.0 Million BGN or by 6.9% less than the same month of the previous year.




Figure 3. Nominal value¹ change of exports of Bulgaria in the period 2015 - 2016 (Compared to the same month of the previous year)

The total value of **all the goods imported** in the country in the period **January - April 2016** amounted to 15 504.4 Million BGN (at CIF prices), or by 8.0% less than the corresponding period of 2015 (Annex, Table 1 and 2).

In **April 2016 the total imports** decreased by 11.3% compared to the same month of the previous year and added up to 4 012.6 Million BGN.




Figure 4. Nominal value¹ change of imports of Bulgaria in the period 2015 - 2016 (Compared to the same month of the previous year)

The total foreign trade balance (exports FOB - import CIF) was negative in the period January - April 2016 and amounted to 1 278.3 Million BGN (Annex, Table 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January - April 2016 the total foreign trade balance was also negative and added up 277.2 Million BGN.

In **April 2016** the total foreign trade balance (exports FOB - import CIF) was negative and amounted to 379.6 Million BGN. The trade balance at FOB/FOB prices was also negative and added up 156.8 Million BGN.
