



BULGARIAN TRADE WITH THIRD COUNTRIES IN THE PERIOD JANUARY - MARCH 2018 (PRELIMINARY DATA)

In the period **January - March 2018** Bulgarian **exports to third countries** decreased by 17.4% in comparison with the same period of 2017 and added up to 3 504.9 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, the Former Yugoslav Republic of Macedonia, the United States and the Russian Federation which accounted for 55.0% of the exports to non EU countries (Annex, Table 3).

In March 2018 Bulgarian **exports to third countries** decreased by 10.4% compared to the corresponding month of the previous year and amounted to 1 264.0 Million BGN.



In the period **January - March 2018** in the exports of Bulgaria to third countries distributed according to the **Standard International Trade Classification** the largest growths compared to the same period of 2017 were recorded in the sections 'Animals and vegetable oils, fats and waxes' (26.7%) and 'Chemical and related products n.e.c.' (14.2%) (Annex, Table 4). The most notable falls were reported in sections 'Mineral fuel, lubricants and related materials' (60.8%) and 'Beverages and tobacco' (50.5%).

Bulgarian imports from third countries in the period **January - March 2018** decreased by 4.0% in comparison with the same period of 2017 and added up to 4 955.2 Million BGN (at CIF prices) (Annex, Table 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Serbia (Annex, Table 3).

In March 2018 Bulgarian imports from third countries decreased by 25.6% compared to the corresponding month of the previous year and amounted to 1 471.9 Million BGN.




Figure 2. Nominal value¹ change of imports of Bulgaria to non EU countries in the period 2017 - 2018

In The period **January - March 2018** in the imports of Bulgaria from third countries distributed according to the **Standard International Trade Classification** the largest growths compared to the same period of 2017 were recorded in the section 'Animals and vegetable oils, fats and waxes' (48.1%) and 'Beverages and tobacco' (31.7%) (Annex, Table 4). The most notable fall was observed in sector "Mineral fuel, lubricants and related materials"(32.0%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - March 2018 was negative and added up to 1 450.3 Million BGN (Annex, Table 1). The trade balance at FOB/FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 1 091.6 Million BGN.

In March 2018 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and amounted to 207.9 Million BGN.

Bulgarian trade with third countries and EU - total

In the **period January - March 2018** the value of **all the goods exported** from Bulgaria amounted to 12 464.7 Million BGN and in comparison with the same period of 2017 the exports increased by 2.4% (Annex, Table 1 and 2).

In **March 2018** the total exports added up to 4 443.6 Million BGN and increased by 1.6% compared to the corresponding month of the previous year.




Figure 3. Nominal value¹ change of exports of Bulgaria in the period 2017 - 2018 (Compared to the same month of the previous year)


The total value of **all the goods imported** in the country in the period January - March 2018 amounted to 14 756.3 Million BGN (at CIF prices), or by 5.7% more than the same period of 2017 (Annex, Table 1 and 2).

In **March 2018** the total imports decreased by 3.4% compared to the same month of the previous year and added up to 5 127.9 Million BGN.

The **total foreign trade balance** (exports FOB - import CIF) was negative in the period January - March 2018 and amounted to 2 291.6 Million BGN (Annex, Table 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January - March 2018 the total foreign trade balance was also negative and added up to 1 377.4 Million BGN.

In **March 2018** the total foreign trade balance (exports FOB - import CIF) was negative and added up to 684.3 Million BGN. The trade balance at FOB/FOB prices was also negative and amounted to 400.5 Million BGN.
