




TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - JUNE 2019 (PRELIMINARY DATA)

In **the period January - June 2019 the exports** of goods from Bulgaria **to third countries** increased by 9.1% in comparison with the same period of the previous year and added up to 8 828.7 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, the Russian Federation, the United States and the Republic of North Macedonia which accounted for 50.1% of the exports to non EU countries (Annex, Table 3).

In **June 2019** the **exports** of goods from Bulgaria **to third countries** decreased by 11.7% compared to the corresponding month of the previous year and amounted to 1 438.5 Million BGN.

In **the period January - June 2019** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growths compared to the same period of the previous year were recorded in sections 'Animals and vegetable oils, fats and waxes' (51.7%) and 'Mineral fuel, lubricants and related materials' (29.4%) (Annex, Table 4). The most notable fall was reported in section 'Manufactured goods classified chiefly by material' (13.3%).




Imports of goods to Bulgaria **from third countries** in **the period January - June 2019** decreased by 1.4% in comparison with same period of 2018 and added up to 10 426.8 Million BGN (at CIF prices) (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Serbia (Annex, Table 3).

In **June 2019** the imports of goods to Bulgaria from third countries decreased by 30.2% compared to the corresponding month of the previous year and amounted to 1 440.6 Million BGN.

In **the period January - June 2019** in the imports of goods to Bulgaria from third countries distributed according to the **Standard International Trade Classification** the largest growths compared to the same period of the previous year were recorded in the section 'Animals and vegetable oils, fats and waxes' (27.3%) and 'Food and live animals' (21.6%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (12.5%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - June 2019 was negative and added up to 1598.1 Million BGN (Annex, Table 1). The trade balance at FOB/FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 691.5 Million BGN.

In **June 2019** the foreign trade balance of Bulgaria (**export FOB - import CIF**) with third countries was negative and amounted to 2.1 Million BGN.




Trade in goods of Bulgaria with third countries and EU - total

In **the period January - June 2019** the total value of **all the goods exported** from Bulgaria amounted to 27 840.5 Million BGN which is 6.3% more than the same period of the previous year (Annex, Tables 1 and 2).

In **June 2019** the total exports of goods added up to 4 524.4 Million BGN and decreased by 6.4% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - June 2019** amounted to 30 508.9 Million BGN (at CIF prices), or by 0.4% more than the same period of 2018 (Annex, Tables 1 and 2).


In **June 2019** the total imports of goods decreased by 14.3% compared to the same month of the previous year and added up to 4 713.1 Million BGN.

The total foreign trade balance (exports FOB - import CIF) was negative in the period January - June 2019 and amounted to 2 668.4 Million BGN (Annex, Tables 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January - June 2019 the total foreign trade balance was also negative and added up to 579.2 Million BGN.

In **June 2019** the total foreign trade balance (exports FOB - import CIF) was negative and added up to 188.7 Million BGN. The trade balance at FOB/FOB prices was positive and amounted to 104.5 Million BGN.
