




TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN 2019 (PRELIMINARY DATA)

In **2019 the exports** of goods from Bulgaria **to third countries** increased by 4.4% in comparison with 2018 and added up to 19 130.4 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, the United States, the Russian Federation and the Republic of North Macedonia which accounted for 50.6% of the exports to non EU countries (Annex, Table 3).

In **December 2019** the **exports** of goods from Bulgaria **to third countries** increased by 2.8% compared to the corresponding month of the previous year and amounted to 1 580.7 Million BGN.

In **2019** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growths compared to 2018 were recorded in sections 'Food and live animals' (59.4%) and 'Crude materials, inedible (except fuel)' (23.8%) (Annex, Table 4). The most notable fall was reported in section 'Manufactured goods classified chiefly by material' (20.2%).




Imports of goods to Bulgaria **from third countries** in **2019** decreased by 11.9% in comparison with 2018 and added up to 20 245.7 Million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Turkey, the Russian Federation, China and Serbia (Annex, Table 3).

In **December 2019** the imports of goods to Bulgaria from third countries decreased by 4.0% compared to the corresponding month of the previous year and amounted to 1 738.4 Million BGN.

In **2019** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growths compared to 2018 were recorded in the sections 'Food and live animals' (21.5%), 'Animals and vegetable oils, fats and waxes' (16.8%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (42.2%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in 2019 was negative and added up to 1 115.3 Million BGN (Annex, Table 1).

In December 2019 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 157.7 Million BGN.




Trade in goods of Bulgaria with third countries and EU - total

In **2019** the total value of **all the goods exported** from Bulgaria amounted to 57 901.4 Million BGN which is 3.3% more than 2018 (Annex, Tables 1 and 2).

In **December 2019** the total exports of goods added up to 4 127.8 Million BGN and decreased by 2.0% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **2019** amounted to 61 272.8 Million BGN (at CIF prices), or by 2.5% less than 2018 (Annex, Tables 1 and 2).

In **December 2019** the total imports of goods increased by 1.4% compared to the same month of the previous year and added up to 4 947.2 Million BGN.



The **total foreign trade balance** (exports FOB - import CIF) was negative in 2019 and amounted to 3 371.4 Million BGN (Annex, Tables 1 and 2).

In December 2019 the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 819.4 Million BGN.
