





# TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - SEPTEMBER 2020 (PRELIMINARY DATA)

In **the period January - September 2020 the exports** of goods from Bulgaria **to third countries** decreased by 11.2% in comparison with the same period of 2019 and added up to 13 639.6 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, the United Kingdom, the United States, Serbia, the Republic of North Macedonia and the Russian Federation which accounted for 54.9% of the exports to non EU countries (Annex, Table 3).

In **September 2020** the **exports** of goods from Bulgaria **to third countries** dropped by 9.0% compared to the corresponding month of the previous year and amounted to 1 649.2 Million BGN.





In **the period January - September 2020** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2019 was recorded in sections 'Animals and vegetable oils, fats and waxes' (55.4%) and 'Crude materials, inedible (except fuel)'<sup>2</sup> (9.6%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (57.5%).




**Imports** of goods to Bulgaria **from third countries** in **the period January - September 2020** decreased by 12.1% in comparison with the same period of 2019 and added up to 16 636.2 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Turkey, the Russian Federation, China and Serbia (Annex, Table 3).

In **September 2020** the imports of goods to Bulgaria from third countries dropped by 6.4% compared to the corresponding month of the previous year and amounted to 2 041.9 Million BGN.

In **the period January - September 2020** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2019 was recorded in the sections 'Crude materials, inedible (except fuel)' (78.7%) and 'Animals and vegetable oils, fats and waxes' (41.4%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (51.2%).

**The foreign trade balance** of Bulgaria (export FOB - import CIF) with third countries in **the period January - September 2020** was negative and added up to 2 996.6 Million BGN (Annex, Table 1).

In **September 2020** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 392.7 Million BGN.




## Trade in goods of Bulgaria with third countries and EU - total

In **the period January - September 2020** the total value of **all the goods exported** from Bulgaria amounted to 40 069.2 Million BGN which is 7.7% less than the same period of 2019 (Annex, Tables 1 and 2).

In **September 2020** the total exports of goods added up to 4 833.1 Million BGN and decreased by 1.8% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - September 2020** amounted to 43 105.5 Million BGN (at CIF prices), or by 11.3% less than the same period of 2019 (Annex, Tables 1 and 2).


In **September 2020** the total imports of goods decreased by 1.4% compared to the same month of the previous year and added up to 5 288.7 Million BGN.



The total foreign trade balance (exports FOB - import CIF) was negative in the period January - September 2020 and amounted to 3 036.3 Million BGN (Annex, Tables 1 and 2).

In **September 2020** the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 455.6 Million BGN.
