




TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN 2020 (PRELIMINARY DATA)

In **2020 the exports** of goods from Bulgaria **to third countries** decreased by 11.3% in comparison with 2019 and added up to 18 686.2 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, the United Kingdom, the United States, Serbia, the Republic of North Macedonia and the Russian Federation, which accounted for 55.0% of the exports to non EU countries (Annex, Table 3).

In **December 2020** the **exports** of goods from Bulgaria **to third countries** dropped by 1.0% compared to the corresponding month of the previous year and amounted to 1 727.9 Million BGN.

In **2020** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to 2019 was recorded in section 'Animals and vegetable oils, fats and waxes' (39.7%) (Annex, Table 4). The most notable fall was reported in sections 'Mineral fuel, lubricants and related materials' (59.7%) and 'Beverages and tobacco' (27.1%).

Imports of goods to Bulgaria **from third countries** in **2020** decreased by 10.2% in comparison with 2019 and added up to 23 118.5 Million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest






amounts were reported for the goods imported from Turkey, the Russian Federation, China, Serbia and Ukraine (Annex, Table 3).

In **December 2020** the imports of goods to Bulgaria from third countries decreased by 15.7% compared to the corresponding month of the previous year and amounted to 1 985.4 Million BGN.

In **2020** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to 2019 was recorded in the sections 'Animals and vegetable oils, fats and waxes' (80.8%) and 'Crude materials, inedible (except fuel)'³ (73.4%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (50.6%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in **2020** was negative and added up to 4 432.3 Million BGN (Annex, Table 1).


In **December 2020** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 257.5 Million BGN.

Trade in goods of Bulgaria with third countries and EU - total

In **2020** the total value of **all the goods exported** from Bulgaria amounted to 54 450.2 Million BGN which is 6.9% less than 2019 (Annex, Tables 1 and 2).

In **December 2020** the total exports of goods added up to 4 432.2 Million BGN and increased by 5.6% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **2020** amounted to 59 652.4 Million BGN (at CIF prices), or by 9.6% less than 2019 (Annex, Tables 1 and 2).


In **December 2020** the total imports of goods decreased by 6.2% compared to the same month of the previous year and added up to 5 158.7 Million BGN.

The **total foreign trade balance** (exports FOB - import CIF) was negative in **2020** and amounted to 5 202.2 Million BGN (Annex, Tables 1).

In December 2020 the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 726.5 Million BGN.
