




### TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - MAY 2021 (PRELIMINARY DATA)

In the period January - May 2021 the exports of goods from Bulgaria to third countries increased by 12.1% in comparison with the same period of 2020 and added up to 8 742.1 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, the United States, Serbia, the United Kingdom, the Republic of North Macedonia and the Russian Federation, which accounted for 56.0% of the exports to non EU countries (Annex, Table 3).

In May 2021 the exports of goods from Bulgaria to third countries grew by 34.4% compared to the corresponding month of the previous year and amounted to 1 725.2 Million BGN.

In the period January - May 2021 in the exports of goods from Bulgaria to third countries, distributed according to the Standard International Trade Classification, the most notable growth compared to the same period of 2020 was recorded in sections 'Manufactured goods classified chiefly by material'<sup>2</sup> (30.5%) and 'Crude materials, inedible (except fuel)' (29.8%) (Annex, Table 4). The most notable fall was reported in sections 'Animals and vegetable oils, fats and waxes' (30.8%) and 'Beverages and tobacco' (26.9%).




**Imports** of goods to Bulgaria **from third countries** in **the period January - May 2021** increased by 20.2% in comparison with the same period of 2020 and added up to 11 280.7 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Turkey, the Russian Federation, China and Ukraine (Annex, Table 3).

In **May 2021 the imports** of goods to Bulgaria **from third countries** grew by 41.2% compared to the corresponding month of the previous year and amounted to 2 310.8 Million BGN.

In **the period January - May 2021** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2020 was recorded in the sections 'Crude materials, inedible (except fuel)' (29.1%) and 'Miscellaneous manufactured articles' (23.9%) (Annex, Table 4). Fall was not observed in any of the sections.

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - May 2021 was negative and added up to 2 538.6 Million BGN (Annex, Table 1).

In **May 2021** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 585.6 Million BGN.




#### Trade in goods of Bulgaria with third countries and EU - total

In **the period January - May 2021** the total value of **all the goods exported** from Bulgaria amounted to 26 355.3 Million BGN which is 19.4% more than the same period of 2020 (Annex, Tables 1 and 2).

In **May 2021 the total exports** of goods added up to 5 084.7 Million BGN and increased by 32.3% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - May 2021** amounted to 29 158.0 Million BGN (at CIF prices), or by 23.1% more than the same period of 2020 (Annex, Tables 1 and 2).


In **May 2021 the total imports** of goods increased by 46.7% compared to the same month of the previous year and added up to 5 991.3 Million BGN.

The total foreign trade balance (exports FOB - import CIF) was negative in the period January - May 2021 and amounted to 2 802.7 Million BGN (Annex, Table 1).

In **May 2021** the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 906.6 Million BGN.
