
TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - AUGUST 2022 (PRELIMINARY DATA)

In **the period January - August 2022, the exports** of goods from Bulgaria **to third countries** increased by 35.8% in comparison with the same period of 2021 and added up to 20 479.4 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Turkey, Serbia, Ukraine, the United States, the Republic of North Macedonia, the United Kingdom and China, which accounted for 50.2% of the exports to non-EU countries (Annex, Table 3).

In **August 2022**, the **exports** of goods from Bulgaria **to third countries** increased by 30.8% compared to the corresponding month of the previous year and amounted to 2 707.2 million BGN.

In **the period January - August 2022**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2021 was recorded in the sections 'Mineral fuel, lubricants and related materials' (203.3%) and 'Animal and vegetable oils, fats and waxes' (123.1%) (Annex, Table 4). A fall was reported in the section 'Manufactured goods classified chiefly by material' (11.7%).



Imports of goods to Bulgaria **from third countries** in **the period January - August 2022** increased by 63.1% in comparison with the same period of 2021 and added up to 31 495.8 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

In **August 2022, the imports** of goods to Bulgaria **from third countries** increased by 36.8% compared to the corresponding month of the previous year and amounted to 3 799.4 million BGN.

In **the period January - August 2022,** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2021 was recorded in the sections 'Animal and vegetable oils, fats and waxes' (378.7%) and 'Mineral fuel, lubricants and related materials' (126.5%) (Annex, Table 4).

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in the period January - August 2022 was negative and added up to 11 016.4 million BGN (Annex, Table 1).

In **August 2022**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 092.2 million BGN.



Trade in goods of Bulgaria with third countries and the EU - total

In the period January - August 2022, the total value of all the goods exported from Bulgaria amounted to 62 164.8 million BGN, which is 41.6% more than the same period of 2021 (Annex, Tables 1 and 2).

In **August 2022, the total exports** of goods added up to 7 873.8 million BGN and increased by 40.5% compared to the corresponding month of the previous year.

Figure 3. Nominal value¹ change of exports of goods from Bulgaria in the period 2021 - 2022 (Compared to the same month of the previous year)




The total value of **all the goods imported** into the country in **the period January - August 2022** amounted to 70 223.1 million BGN (at CIF prices), or 45.3% more than in the same period of 2021 (Annex, Tables 1 and 2).

In **August 2022, the total imports** of goods increased by 37.2% compared to the same month of the previous year and added up to 8 578.7 million BGN.

The total foreign trade balance (exports FOB - imports CIF) was negative in the period January - August 2022 and amounted to 8 058.3 million BGN (Annex, Table 1).

In **August 2022**, the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 704.9 million BGN.
