
TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN 2022 (PRELIMINARY DATA)

In **2022**, the exports of goods from Bulgaria to third countries increased by 35.5% in comparison with 2021 and added up to 31 391.4 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Turkey, Ukraine, Serbia, the United States, China, the Republic of North Macedonia and the United Kingdom, which accounted for 51.8% of the exports to non-EU countries (Annex, Table 3).

In **December 2022**, the **exports** of goods from Bulgaria **to third countries** increased by 11.2% compared to the corresponding month of the previous year and amounted to 2 387.6 million BGN.

In **2022**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to 2021 was recorded in the sections 'Mineral fuel, lubricants and related materials' (218.7%) and 'Animal and vegetable oils, fats and waxes' (195.4%) (Annex, Table 4). The most notable fall was reported in the section 'Manufactured goods classified chiefly by material' (6.8%).



Imports of goods to Bulgaria **from third countries** in **2022** increased by 58.8% in comparison with 2021 and added up to 48 288.9 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

In **December 2022, the imports** of goods to Bulgaria **from third countries** increased by 20.3% compared to the corresponding month of the previous year and amounted to 3 453.1 million BGN.

In **2022,** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification,** the largest growth compared to 2021 was recorded in the sections 'Animal and vegetable oils, fats and waxes' (560.6%) and 'Mineral fuel, lubricants and related materials' (126.0%) (Annex, Table 4).

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in 2022 was negative and added up to 16 897.5 million BGN (Annex, Table 1).

In **December 2022**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 065.5 million BGN.



Trade in goods of Bulgaria with third countries and the EU – total

In **2022**, the total value of **all the goods exported** from Bulgaria amounted to 94 372.8 million BGN, which is 37.9% more than 2021 (Annex, Tables 1 and 2).

In **December 2022, the total exports** of goods added up to 6 920.4 million BGN and increased by 14.5% compared to the corresponding month of the previous year.

Figure 3. Nominal value¹ change of exports of goods from Bulgaria in the period 2021 - 2022 (Compared to the same month of the previous year)




The total value of **all the goods imported** into the country in **2022** amounted to 108 305.8 million BGN (at CIF prices), or 41.1% more than in 2021 (Annex, Tables 1 and 2).

In **December 2022, the total imports** of goods increased by 13.5% compared to the same month of the previous year and added up to 8 356.1 million BGN.

The total foreign trade balance (exports FOB - imports CIF) was negative in **2022** and amounted to 13 933.0 million BGN (Annex, Table 1).

In **December 2022,** the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 1 435.7 million BGN.
