



TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN JANUARY 2023 (PRELIMINARY DATA)

In **January 2023**, the exports of goods from Bulgaria to third countries increased by 24.4% in comparison with January 2022 and added up to 2 634.4 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Türkiye, the United Kingdom, Ukraine, the United States, Gibraltar, Switzerland and Serbia, which accounted for 54.0% of the exports to non-EU countries (Annex, Table 3).






In **January 2023**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to January 2022 was recorded in the sections 'Machinery and transport equipment' (99.5%) and 'Animal and vegetable oils, fats and waxes' (92.5%) (Annex, Table 4). The most notable fall was reported in the section 'Crude materials, inedible (except fuel)' (30.2%).

Imports of goods to Bulgaria **from third countries** in **January 2023** increased by 0.8% in comparison with January 2022 and added up to 3 539.0 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Türkiye, China and Ukraine (Annex, Table 3).

In **January 2023**, in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to January 2022 was recorded in the sections 'Animal and vegetable oils, fats and waxes' (391.0%) and 'Beverages and tobacco' (33.7%) (Annex, Table 4). The most notable fall was reported in the section 'Manufactured goods classified chiefly by material'³ (19.3%).

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in **January 2023** was negative and added up to 904.6 million BGN (Annex, Table 1).





Trade in goods of Bulgaria with third countries and the EU - total

In **January 2023**, the total value of **all the goods exported** from Bulgaria amounted to 7 689.1 million BGN, which is 22.8% more than the corresponding month of the previous year (Annex, Tables 1 and 2).







The total value of **all the goods imported** into the country in **January 2023** amounted to 8 178.7 million BGN (at CIF prices), or 6.9% more than in January 2022 (Annex, Tables 1 and 2).

The total foreign trade balance (exports FOB - imports CIF) was negative in January 2023 and amounted to 489.6 million BGN (Annex, Table 1).
