
# TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - NOVEMBER 2023 (PRELIMINARY DATA)

In **the period January - November 2023, the exports** of goods from Bulgaria **to third countries** decreased by 3.5% in comparison with the same period of 2022 and added up to 28 782.0 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Türkiye, China, the United States, Serbia, Ukraine, the Republic of North Macedonia and Egypt, which accounted for 50.1% of the exports to non-EU countries (Annex, Table 3).

In the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth was recorded in the sections 'Beverages and tobacco' (22.0%) and 'Food and live animals' (21.4%) (Annex, Table 4). The most notable fall was reported in the section 'Mineral fuel, lubricants and related materials' (30.9%).


In **November 2023**, the **exports** of goods from Bulgaria **to third countries** decreased by 20.4% compared to the corresponding month of the previous year and amounted to 2 501.7 million BGN.

**Imports** of goods to Bulgaria **from third countries** in **the period January - November 2023** decreased by 20.3% in comparison with the same period of 2022 and added up to 35 707.8 million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Türkiye, the Russian Federation, China and Serbia (Annex, Table 3).

In the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth was recorded in the sections 'Beverages and tobacco' (14.6%) and 'Food and live animals' (13.0%) (Annex, Table 4). The most notable fall was reported in the section 'Animal and vegetable oils, fats and waxes' (49.1%).

In November 2023, the imports of goods to Bulgaria from third countries decreased by 13.1% compared to the corresponding month of the previous year and amounted to 3 526.0 million BGN.

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in the period **January - November 2023** was negative and added up to 6 925.8 million BGN (Annex, Table 1).

In **November 2023**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 024.3 million BGN.





#### Trade in goods of Bulgaria with third countries and the EU - total

In **the period January - November 2023**, the total value of **all the goods exported** from Bulgaria amounted to 80 056.0 million BGN, which is 7.1% less than the corresponding period of the previous year (Annex, Tables 1 and 2).

In **November 2023**, the total exports of goods added up to 7 016.8 million BGN and decreased by 18.0% compared to the corresponding month of the previous year.






The total value of **all the goods imported** into the country in **the period January - November 2023** amounted to 89 054.9 million BGN (at CIF prices), or 10.5% less than in the period January - November 2022 (Annex, Tables 1 and 2).

In **November 2023,** the total imports of goods decreased by 10.3% compared to the same month of the previous year and added up to 8 614.4 million BGN.

The total foreign trade balance (exports FOB - imports CIF) was negative in the period January - November 2023 and amounted to 8 998.9 million BGN (Annex, Table 1).

**In November 2023,** the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 1 597.6 million BGN.
