


TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - FEBRUARY 2024 (PRELIMINARY DATA)

In the period January - February 2024, the exports of goods from Bulgaria to third countries decreased by 9.3% in comparison with the same period of 2023 and added up to 4 465.0 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Türkiye, the United States, the Republic of North Macedonia, China, Serbia, the United Kingdom and Gibraltar, which accounted for 50.6% of the exports to non-EU countries (Annex, Table 3).

In **February 2024** the **exports** of goods from Bulgaria **to third countries** decreased by 7.1% compared to the corresponding month of the previous year and amounted to 2 318.0 million BGN.

In the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth was recorded in the sections 'Chemical and related products n.e.c.' (12.9%) and 'Crude materials, inedible (except fuel)' (7.9%) (Annex, Table 4). The most notable fall was reported in the section 'Beverages and tobacco' (47.6%).

Imports of goods to Bulgaria **from third countries** in **the period January - February 2024** decreased by 13.2% in comparison with the same period of 2023 and added up to 5 886.5 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Türkiye, China, the Russian Federation, and Ukraine (Annex, Table 3).

In February 2024 the imports of goods to Bulgaria **from third countries** decreased by 7.6% compared to the corresponding month of the previous year and amounted to 2 975.4 million BGN.




Figure 2. Nominal value² change of imports of goods to Bulgaria from non-EU countries in the period 2023 - 2024 (Compared to the same month of the previous year)

In the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth was recorded in the section 'Animal and vegetable oils, fats and waxes' (6.2%) (Annex, Table 4). The most notable fall was reported in the section 'Crude materials, inedible (except fuel)' (27.1%).

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in **the period January - February 2024** was negative and added up to 1 421.5 million BGN (Annex, Table 1).

In February 2024 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 657.4 million BGN.

Trade in goods of Bulgaria with third countries and the EU - total

In the period January - February 2024, the total value of all the goods exported from Bulgaria amounted to 12 808.8 million BGN, which is 11.4% less than the same month of the previous year (Annex, Tables 1 and 2).

In February 2024 the total exports of goods added up to 6 567.3 million BGN and decreased by 7.5% compared to the corresponding month of the previous year.





Figure 3. Nominal value¹ change of exports of goods from Bulgaria in the period 2023 - 2024 (Compared to the same month of the previous year)


The total value of **all the goods imported** into the country in **the period January - February 2024** amounted to 15 097.0 million BGN (at CIF prices), or 6.8% less than the same period of 2023 (Annex, Tables 1 and 2).

In February 2024 the total imports of goods decreased by 5.4% compared to the same month of the previous year and added up to 7 629.2 million BGN.

The total foreign trade balance (exports FOB - imports CIF) was negative in the period January - February 2024 and amounted to 2 288.2 million BGN (Annex, Table 1).

In February 2024 the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 1 061.9 million BGN.
