


BULGARIAN TRADE WITH EU IN THE PERIOD JANUARY - MARCH 2019 (PRELIMINARY DATA)

In the period **January - March 2019** Bulgarian **exports to the EU** grew by 7.0% in comparison with the same period of 2018 and amounted to 9 607.1 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, France and Belgium which accounted for 67.3% of the exports to the EU Member States (Annex, Table 3).

In **March 2019** the exports to the EU grew by 2.9% compared to the corresponding month of the previous year and amounted to 3 274.3 Million BGN.

Figure 1. Nominal value¹ change of exports of goods of Bulgaria to EU in the period 2018 - 2019 (Compared to the same month of the previous year)




In the period **January** - **March 2019** in comparison to the corresponding period of the previous year the largest growth in the exports of Bulgaria to the EU distributed according to the **Standard International Trade Classification** (Annex, Table 4) was recorded in the section 'Mineral fuel, lubricants and related materials' (75.4%). The most notable fall was recorded in the section 'Animals and vegetable oils, fats and waxes' (8.4%).



Bulgarian **imports from the EU** in the period **January - March 2019** increased by 0.3% compared to same period of 2018 and reached 9 817.8 Million BGN at CIF prices (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Italy, Romania, Greece and Hungary (Annex, Table 3).

In **March 2019** the Bulgarian imports from the EU Member States dropped by 1.7% compared to the corresponding month of the previous year and amounted to 3 586.0 Million BGN.





In the period **January - March 2019** compared to the corresponding period of the previous year the largest growth in imports from the EU distributed according to the **Standard International Trade Classification** was reported in the section 'Beverages and tobacco' (50.0%) while the most notable fall was observed in the section 'Crude materials, inedible (except fuel)², (29.4%).

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with the EU** in the period **January** - **March 2019** was negative and added up to 210.7 Million BGN (Annex, Table 1). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the trade balance was positive and amounted to 384.7 Million BGN.
