



## BULGARIAN TRADE WITH EU IN THE PERIOD JANUARY - JULY 2019 (PRELIMINARY DATA)

In the period **January - July 2019** Bulgarian **exports to the EU** grew by 4.8% in comparison with the same period of 2018 and amounted to 22 629.6 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, France and Belgium which accounted for 66.6% of the exports to the EU Member States (Annex, Table 3).

In **July 2019** the exports to the EU grew by 3.0% compared to the corresponding month of the previous year and amounted to 3 600.0 Million BGN.




Figure 1. Nominal value<sup>1</sup> change of exports of goods of Bulgaria to EU in the period 2018 - 2019 (Compared to the same month of the previous year)

In the period **January - July 2019** in comparison to the corresponding period of the previous year the largest growth in the exports of Bulgaria to the EU distributed according to the **Standard International Trade Classification** (Annex, Table 4) was recorded in the section 'Mineral fuel, lubricants and related materials' (46.4%). The most notable fall was recorded in the section 'Animals and vegetable oils, fats and waxes' (17.0%).






Bulgarian **imports from the EU** in the period **January - July 2019** increased by 2.1% compared to same period of 2018 and reached 23 842.7 Million BGN (at CIF prices)<sup>1</sup>(Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Italy, Romania, Greece and Spain (Annex, Table 3).

In **July 2019** the Bulgarian imports from the EU Member States increased by 4.9% compared to the corresponding month of the previous year and amounted to 3 740.7 Million BGN.

In the period **January - July 2019** compared to the corresponding period of the previous year the largest growth in imports from the EU distributed according to the **Standard International Trade Classification** was reported in the section 'Beverages and tobacco' (24.9%) while the most notable fall was observed in the section 'Crude materials, inedible (except fuel)' <sup>3</sup> (28.6%).

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with the EU** in the period **January - July 2019** was negative and added up to 1 213.1 Million BGN (Annex, Table 1).
