





#### BULGARIAN TRADE WITH EU IN JANUARY 2020 (PRELIMINARY DATA)

In **January 2020** Bulgarian **exports to the EU** grew by 4.4% in comparison with the same month of 2019 and amounted to 3 314.7 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Italy, Romania, Greece, Belgium and France which accounted for 66.6% of the exports to the EU Member States (Annex, Table 3).






In **January 2020** in comparison to the corresponding month of the previous year the largest growth in the exports of Bulgaria to the EU distributed according to the **Standard International Trade Classification** (Annex, Table 4) was recorded in the sections 'Animals and vegetable oils, fats and waxes' (129.8%) and 'Beverages and tobacco' (71.1%). The most notable fall was observed in the section 'Mineral fuel, lubricants and related materials' (21.8%).

Bulgarian **imports from the EU** in **January 2020** increased by 4.9% compared to the same month of 2019 and reached 3 150.2 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Greece, Italy and the Netherlands (Annex, Table 3).

In **January 2020** compared to the corresponding month of 2019 the largest growth in the imports from the EU, distributed according to the **Standard International Trade Classification**, was reported in the section 'Mineral fuel, lubricants and related materials' (155.2%) while the most notable fall was observed in the section 'Crude materials, inedible (except fuel)'<sup>3</sup> (38.1%).

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with the EU** in **January 2020** was positive and added up to 164.5 Million BGN (Annex, Table 1).
