




BULGARIAN TRADE WITH EU IN THE PERIOD JANUARY - FEBRUARY 2020 (PRELIMINARY DATA)

In the period **January - February 2020** Bulgarian **exports to the EU**¹ grew by 4.3% in comparison with the same period of 2019 and amounted to 6 377.6 Million BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, Belgium and France which accounted for 70.3% of the exports to the EU Member States (Annex, Table 3).

In **February 2020** the exports to the EU grew by 4.1% compared to the corresponding month of the previous year and amounted to 3 175.1 Million BGN.

In the period **January - February 2020** in comparison to the corresponding period of the previous year the largest growth in the exports of Bulgaria to the EU distributed according to the **Standard International Trade Classification** (Annex, Table 4) was recorded in the sections 'Beverages and tobacco' (44.4%) and 'Animals and vegetable oils, fats and waxes' (32.0%). The most notable fall was observed in the section 'Food and live animals' (11.6%).




HAD years BULGARIAN STATISTICS

Bulgarian **imports from the EU** in the period **January - February 2020** increased by 3.2% compared to the same period of 2019 and reached 6 294.5 Million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Italy, Greece, and Hungary (Annex, Table 3).

In **February 2020** the Bulgarian imports from the EU Member States grew by 1.4% compared to the corresponding month of the previous year and amounted to 3 207.1 Million BGN.

In the period **January - February 2020** compared to the corresponding period of 2019 the largest growth in the imports from the EU, distributed according to the **Standard International Trade Classification**, was reported in the section 'Mineral fuel, lubricants and related materials' (101.7%) while fall was observed only in the section 'Crude materials, inedible (except fuel)'³ (48.1%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with the EU in the period January - February 2020 was positive and added up to 83.1 Million BGN (Annex, Table 1).
