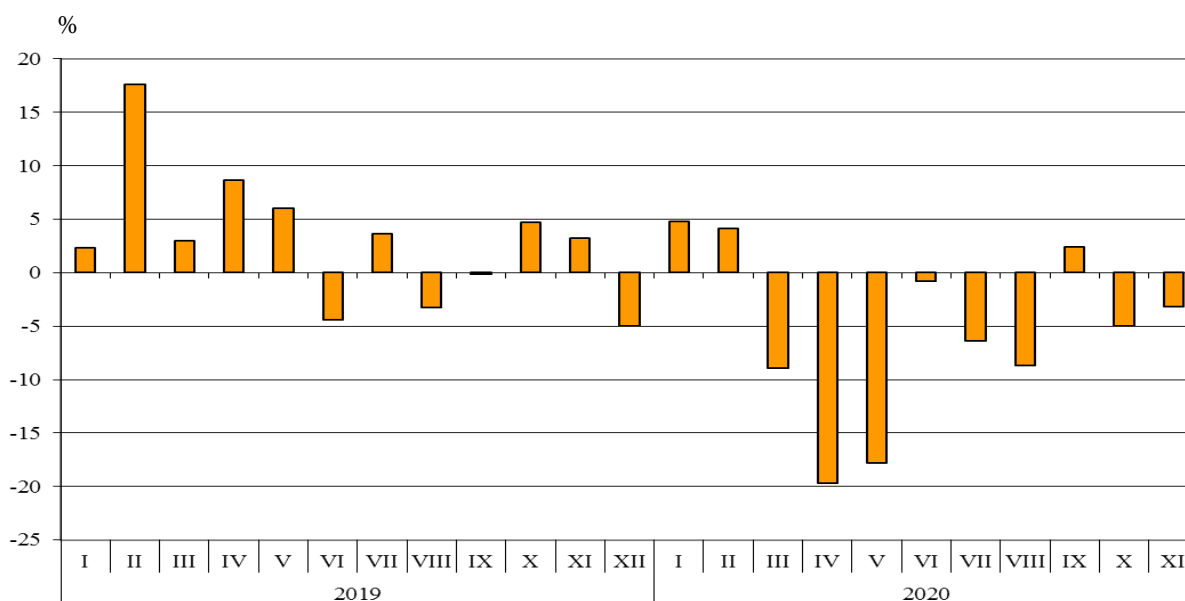


## TRADE IN GOODS OF BULGARIA WITH EU IN THE PERIOD JANUARY - NOVEMBER 2020 (PRELIMINARY DATA)

In the period **January - November 2020** the exports of goods from Bulgaria to the EU decreased by 5.4% in comparison with the same period of 2019 and added up to 33 059.7 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, France and Belgium which accounted for 70.0 % of the exports to the EU Member States (Annex, Table 3).

In **November 2020** the exports of goods from Bulgaria to the EU decreased by 3.2% compared to the corresponding month of the previous year and amounted to 3 297.6 Million BGN.

(Compared to the same month of the previous year)**



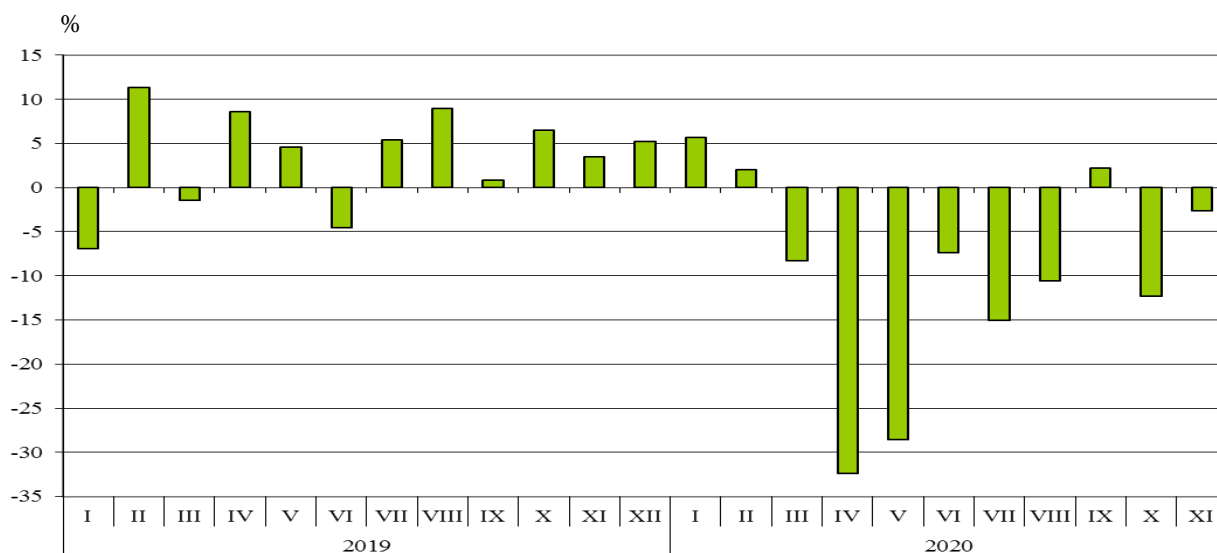
In the period **January - November 2020** in the exports of goods from Bulgaria to the EU, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2019 was recorded in sections 'Animals and vegetable oils, fats and waxes' (28.0%) and 'Beverages and tobacco' (26.9%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (44.2%).

**Imports of goods to Bulgaria from the EU** in the period **January - November 2020** decreased by 10.1% in comparison with the same period of 2019 and added up to 33 360.6 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Italy, Greece and the Netherlands (Annex, Table 3).

In **November 2020** the imports of goods to Bulgaria from the EU Member States dropped by 2.6% compared to the corresponding month of the previous year and amounted to 3 537.4 Million BGN.

In the period **January - November 2020** in the imports of goods to Bulgaria from the EU Member States, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2019 was recorded in the section ‘Animals and vegetable oils, fats and waxes’ (9.7%). The most notable fall was observed in the section ‘Crude materials, inedible (except fuel)’<sup>3</sup> (52.3%).

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with the EU** in the period **January - November 2020** was negative and added up to 300.9 Million BGN (Annex, Table 1).
