
TRADE IN GOODS OF BULGARIA WITH THE EU IN THE PERIOD JANUARY - APRIL 2023 (PRELIMINARY DATA)

In the period **January - April 2023, the exports of goods** from Bulgaria **to the EU** decreased by 1.2% in comparison with the same period of 2022 and added up to 18 960.5 million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece and France, which accounted for 61.8% of the exports to the EU Member States (Annex, Table 3).

In **April 2023**, the exports to the EU decreased by 18.1% compared to the corresponding month of the previous year and amounted to 4 287.2 million BGN.

In the period **January - April 2023**, in the exports of goods from Bulgaria to the EU, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2022 was recorded in the section 'Miscellaneous manufactured articles' (26.8%) (Annex, Table 4). The most notable fall was reported in the section 'Animal and vegetable oils, fats and waxes' (57.3%).



Imports of goods to Bulgaria **from the EU** in the period **January - April 2023** increased by 6.1% in comparison with the same period of 2022 and added up to 19 533.0 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Italy, Romania, Greece and the Netherlands (Annex, Table 3).

In **April 2023**, the imports from the EU decreased by 0.1% compared to the corresponding month of the previous year and amounted to 4 573.1 million BGN.

In the period **January - April 2023**, in the imports of goods to Bulgaria from the EU Member States, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2022 was recorded in the section 'Machinery and transport equipment' (27.4%). The most notable fall was reported in the section 'Mineral fuel, lubricants and related materials' (55.4%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with the EU in the period January - April 2023 was negative and added up to 572.5 million BGN (Annex, Table 1).
