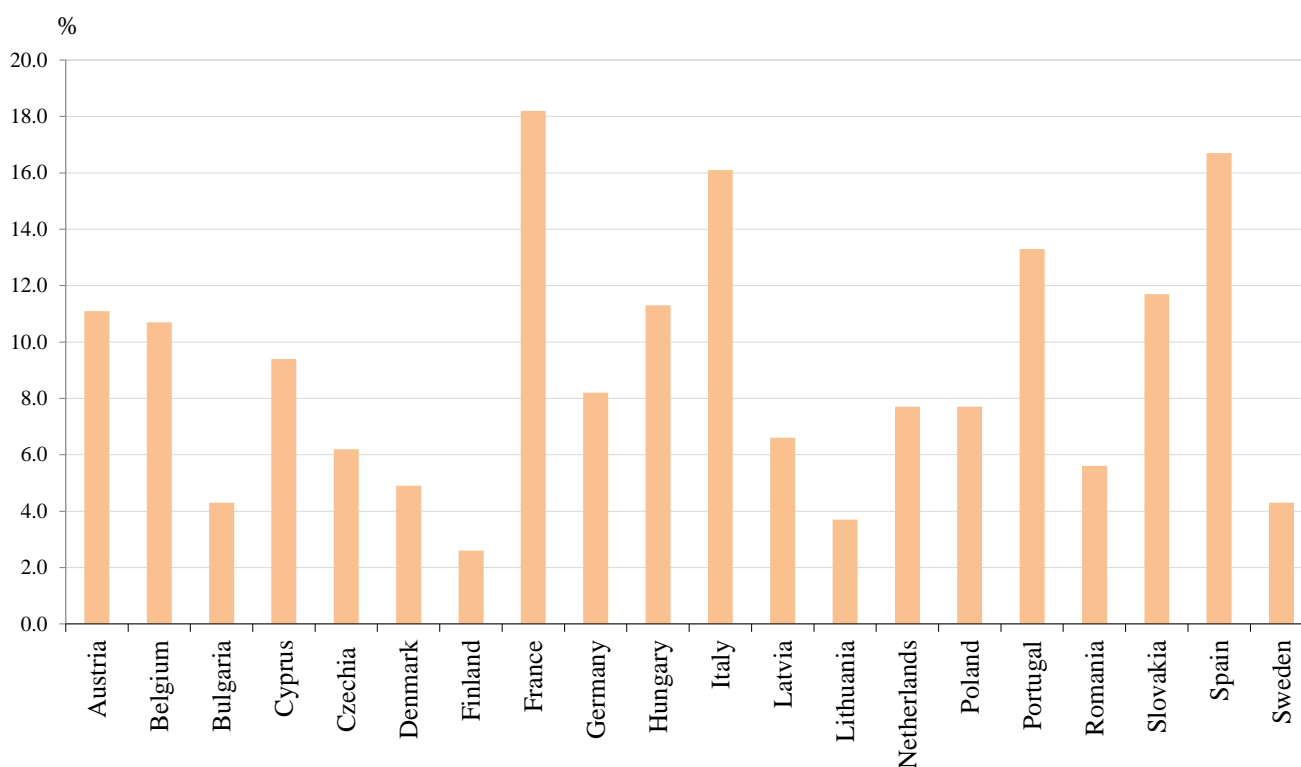


BULGARIA AND EU: GROSS DOMESTIC PRODUCT, THIRD QUARTER OF 2020 (FLASH ESTIMATES)

Gross Domestic Product (GDP) in the third quarter of 2020 increased by 11.6% in EU-27 compared to the previous quarter by seasonally adjusted data. For the same period, GDP in Bulgaria increased by 4.3% (Table 1 of the Annex).

Compared to the previous quarter, in the third quarter of 2020 highest economic increase was recorded in France - 18.2%, Spain - 16.7%, Italy - 16.1% and Portugal - 13.3%. According to the seasonally adjusted figures, lowest growth is observed in Finland - 2.6% and in Lithuania - 3.7%.

(Compared to the previous quarter)**

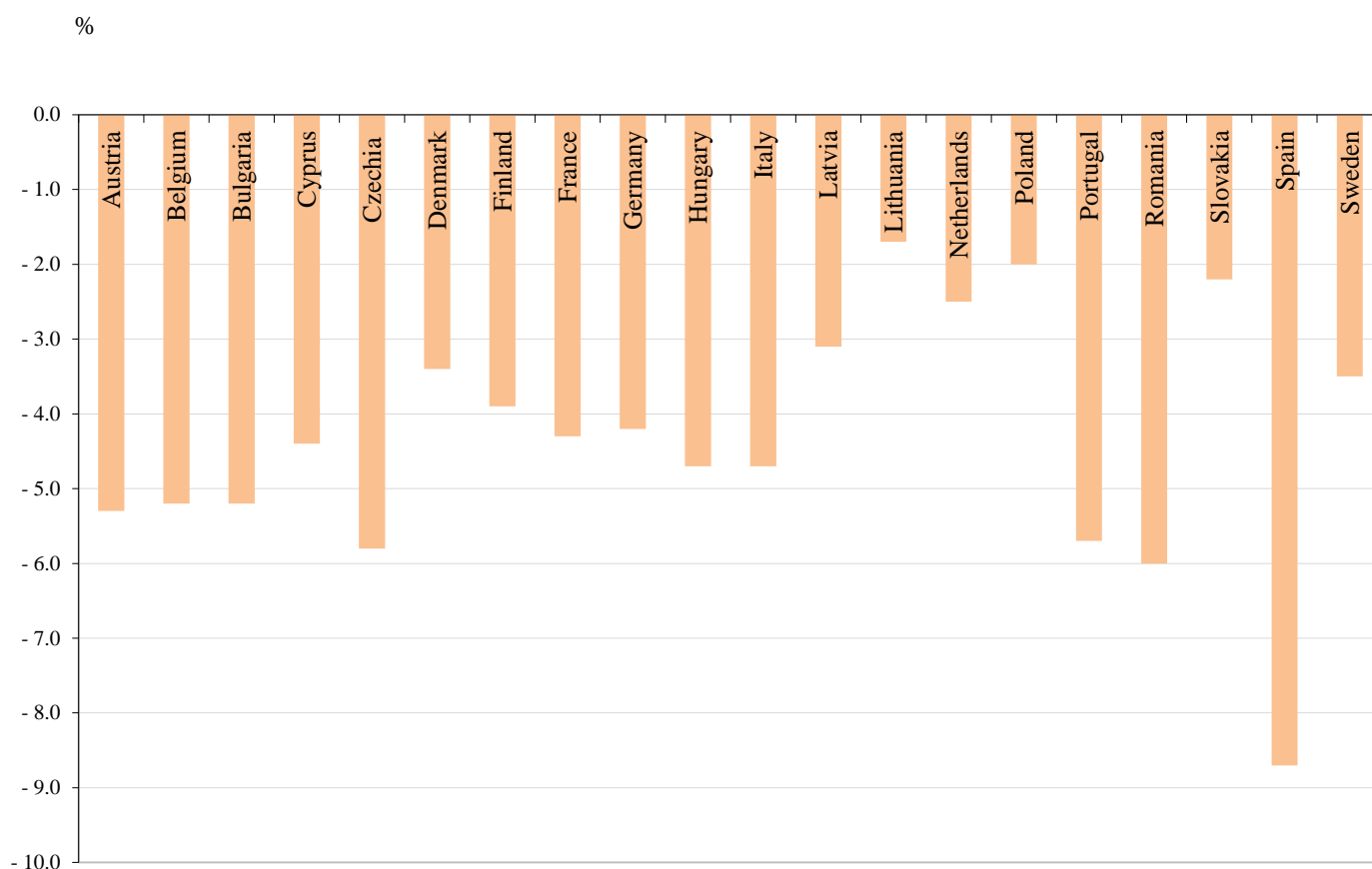

Compared to the same quarter of the previous year, seasonally adjusted data show decrease of GDP in the EU-27 by 4.3%. For the same period, GDP in Bulgaria decreased by 5.2% (Table 1 of the Annex).

In the third quarter of 2020, compared to the same quarter of the previous year lowest economic decline was recorded in Lithuania - 1.7%, Poland - 2.0%, Slovakia - 2.2%, and Netherlands - 2.5%. According to the seasonally adjusted figures, highest negative growth is observed in Spain - 8.7%, Romania - 6.0%, Czechia - 5.8% and Portugal - 5.7%.
