





BULGARIA AND EU: GROSS DOMESTIC PRODUCT, FOURTH QUARTER OF 2019 (PRELIMINARY ESTIMATES)

Gross Domestic Product (GDP) in the fourth quarter of 2019 increased by 0.2% in the EU-27 compared to the previous quarter by seasonally adjusted data. For the same period, GDP in Bulgaria increased by 0.8% (Table 1 of the Annex).

Compared to the previous quarter, in the fourth quarter of 2019, Ireland recorded the highest economic growth - 1.8%, Malta - 1.7%, Romania - 1.5%, Lithuania and Hungary - by 1.0% each. According to the seasonally adjusted figures, negative growth is observed in Finland and Greece - by 0.7% each, Italy - 0.3 and France - 0.1%.



Compared to the same quarter of the previous year, seasonally adjusted data showed an increase of GDP in the EU-27 by 1.2% and in Bulgaria - by 3.1%.

In the fourth quarter of 2019, compared to the same quarter of the previous year, the highest economic growth is observed in Ireland - 6.3%, Hungary - 4.6%, Malta - 4.3%, Romania - 4.2% and Estonia - 4.0%.
