

PRODUCER PRICE INDICES IN INDUSTRY¹

NOVEMBER 2009

1. Producer Price Indices on Domestic Market²

Producer Price Index on Domestic Market in November 2009 rose 0.3% compared to the previous month. The domestic prices increased in the mining and quarrying industry by 2.4% and in the manufacturing by 0.3%, while in the electricity, gas, steam and air conditioning supply the prices decreased by 0.1%.

In the manufacturing the more significant price increase comparing to the previous month were seen in the manufacture of basic metals by 6.8% and in the manufacture of chemicals and chemical products by 0.9%. The prices decreased in the manufacture of other non-metallic mineral products by 1.9%, in the manufacture of machinery and equipment by 1.6% and in the manufacture of fabricated metal products, except machinery and equipment by 1.4%.

Producer Price Index on Domestic Market in November 2009 fell by 5.3% compared to the same month of 2008. The domestic prices decreased in the manufacturing by 6.5% and in the electricity, gas, steam and air conditioning supply by 5.4%, while in the mining and quarrying industry the prices rose 10.5%.


In the manufacturing compared to the same month of 2008, the prices decrease was registered in the manufacture of wood and of products of wood, except furniture by 9.0%, in the manufacture of food products by 5.6%, in the manufacture of rubber and plastic products by 4.0%. The price increase was seen in the manufacture of beverages by 6.8%, in the manufacture of motor vehicles, trailers and semi-trailers by 5.4%, in the manufacture of leather and related products by 4.9%.

¹ Since January 2009, Producer Price Indices are calculated according to the new Classification of Economic Activities NACE.BG 2008. At the same time, the base year has been changed and indices are calculated at 2005 as a base year. Historical data series have been recalculated back to 2000 and they are posted in NSI web-site (http://www.nsi.bg/Index_en.htm).

Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

² Producer Price Indices on domestic market are calculated at constant base (2005) weighed with turnover structure on domestic market.

2. Total Producer Price Indices in Industry³

Total Producer Price Index in Industry in November 2009 increased by 0.5% compared to October 2009. The higher prices were registered in the mining and quarrying industry by 1.9% and in the manufacturing by 0.7%, while in the electricity, gas, steam and air conditioning supply, the prices fell by 0.5%.

In the manufacturing, more significant price increase was seen in the manufacture of basic metals by 3.3%, in the manufacture of chemicals and chemical products by 1.0%, while the prices decreased in the manufacture of other non-metallic mineral products by 1.7%, in the manufacture of fabricated metal products, except machinery and equipment and in the manufacture of computer, electronic and optical products by 1.2% in each activity.


Total Producer Price Index in November 2009 decreased by 5.9% comparing to the same month of 2008.

In the manufacturing, the prices fell by 5.4% as compared to the same month of 2008. More significant price decreases were seen in the manufacture of motor vehicles, trailers and semi-trailer by 19.9%, in the manufacture of wood and of products of wood, except furniture by 8.4%, in the manufacture of motor vehicles, trailers and semi-trailers by 6.9% and in the manufacture of food products by 6.7%, while the producer prices increased in

the manufacture of beverages by 6.4% and in the manufacture of chemicals and chemical products by 3.9% and in the manufacture of wearing apparel by 3.6%.
