



PRODUCER PRICE INDICES IN INDUSTRY¹, DECEMBER 2013

1. Producer Price Indices on Domestic Market²

Producer Price Index on Domestic Market in December 2013 remained at the level of the previous month. The domestic prices fell in the mining and quarrying industry by 1.4%, while in the manufacturing and in the electricity, gas, steam and air conditioning supply the prices did not change.

In the manufacturing³, compared to the previous month the prices went up in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 0.8% and in the manufacture of tobacco products by 0.7%, while a price decrease was reported in the repair and installation of machinery and equipment by 0.5% and in the manufacture of fabricated metal products, except machinery and equipment by 0.4%.

Producer Price Index on Domestic Market in December 2013 decreased by 2.8% compared to the same month of 2012. The domestic prices fell in the mining and quarrying industry by 12.1%, in the manufacturing by 0.8% and in the electricity, gas, steam and air conditioning supply by 5.2%.

In the manufacturing compared to December 2012, a price decrease was registered in the manufacture of basic metals by 6.0%, in the manufacture of chemicals and chemical products by 5.6% and in the manufacture of food products by 4.2%. The prices increases were seen in the manufacture of leather and related products by 8.0%, in the manufacture of tobacco products by 4.2%, in the manufacture of wearing apparel and in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 2.5%.

¹Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.


² Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

2. Total Producer Price Indices in Industry¹

Total Producer Price Index in Industry in December 2013 decreased by 0.2% compared to the previous month. Lower prices were registered in the mining and quarrying industry by 3.2% and in the manufacturing by 0.1%, while the prices in the electricity, gas, steam and air conditioning supply remained at the level of the previous month.

In the manufacturing², more significant prices decreases were seen in the manufacture of basic metals by 1.6%, in the manufacture of leather and related products by 1.2%, in the manufacture of wearing apparel and in the repair and installation of machinery and equipment by 0.5%.

¹ Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Nondomestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year.

Total Producer Price Index in December 2013 decreased by 2.9% comparing to the same month of 2012.

In the manufacturing, the prices declined by 1.3% as compared to December 2012. More significant prices decreases were seen in the manufacture of basic metals by 10.0%, in the manufacture of food products by 3.8% and in the manufacture of motor vehicles, trailers and semi-trailers by 2.6%, while the producer prices rose in the manufacture of fabricated metal products, except machinery and equipment by 2.1%, in the manufacture of wearing apparel by 2.0% and in the manufacture of tobacco products by 1.8%.
