



PRODUCER PRICE INDICES IN INDUSTRY¹, JULY 2014

1. Producer Price Indices on Domestic Market²

Producer Price Index on Domestic Market in July 2014 decreased by 0.1% compared to the previous month. The domestic prices rose in the mining and quarrying industry by 3.3% and in the manufacturing by 0.3%, while in the electricity, gas, steam and air conditioning supply the prices fell by 1.3%.

In the manufacturing³, compared to the previous month, the prices went up in the manufacture of basic metals by 1.9%, in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 0.7% and in the manufacture of beverages by 0.6%, while a price decrease was reported in the repair and installation of machinery and equipment by 0.4%, in the manufacture of food products, in the manufacture of other non-metallic mineral products and in the manufacture of fabricated metal products, except machinery and equipment by 0.2%.

Producer Price Index on Domestic Market in July 2014 decreased by 0.6% compared to the same month of 2013. The domestic prices fell in the mining and quarrying industry by 2.6% and in the electricity, gas, steam and air conditioning supply by 2.4%, while in the manufacturing the prices rose by 0.5%.

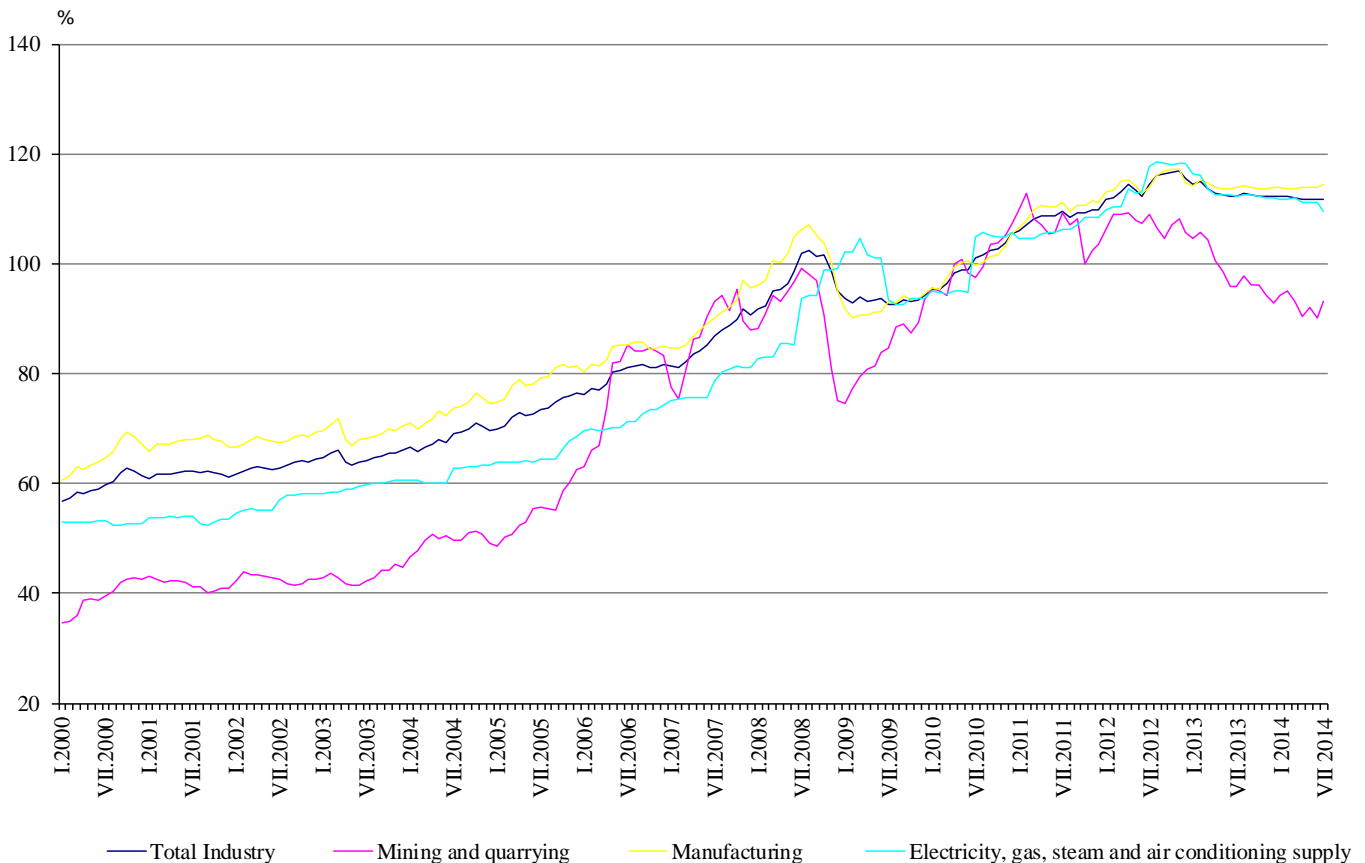
In the manufacturing compared to July 2013, a price increase was registered in the manufacture of tobacco products by 7.6%, in the manufacture of motor vehicles, trailers and semi-trailers by 5.3% and in the manufacture of paper and paper products by 3.5%. The prices decreases were seen in the manufacture of food products by 4.2%, in the manufacture of chemicals and chemical products by 3.3% and in the manufacture of other transport equipment by 2.1%.

¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

² Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

2. Total Producer Price Indices in Industry¹

Total Producer Price Index in Industry in July 2014 increased by 0.2% compared to the previous month. Higher prices were registered in the mining and quarrying industry by 2.6% and in the manufacturing by 0.6%, while the prices in the electricity, gas, steam and air conditioning supply the prices fell by 1.2%.

In the manufacturing², more significant prices increases were seen in the manufacture of basic metals by 3.0%, in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 0.8% and in the manufacture of beverages by 0.6%, while prices decreases were reported in the repair and installation of machinery and equipment by 0.4% and in the manufacture of other non-metallic mineral products by 0.3%.

¹ Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year.

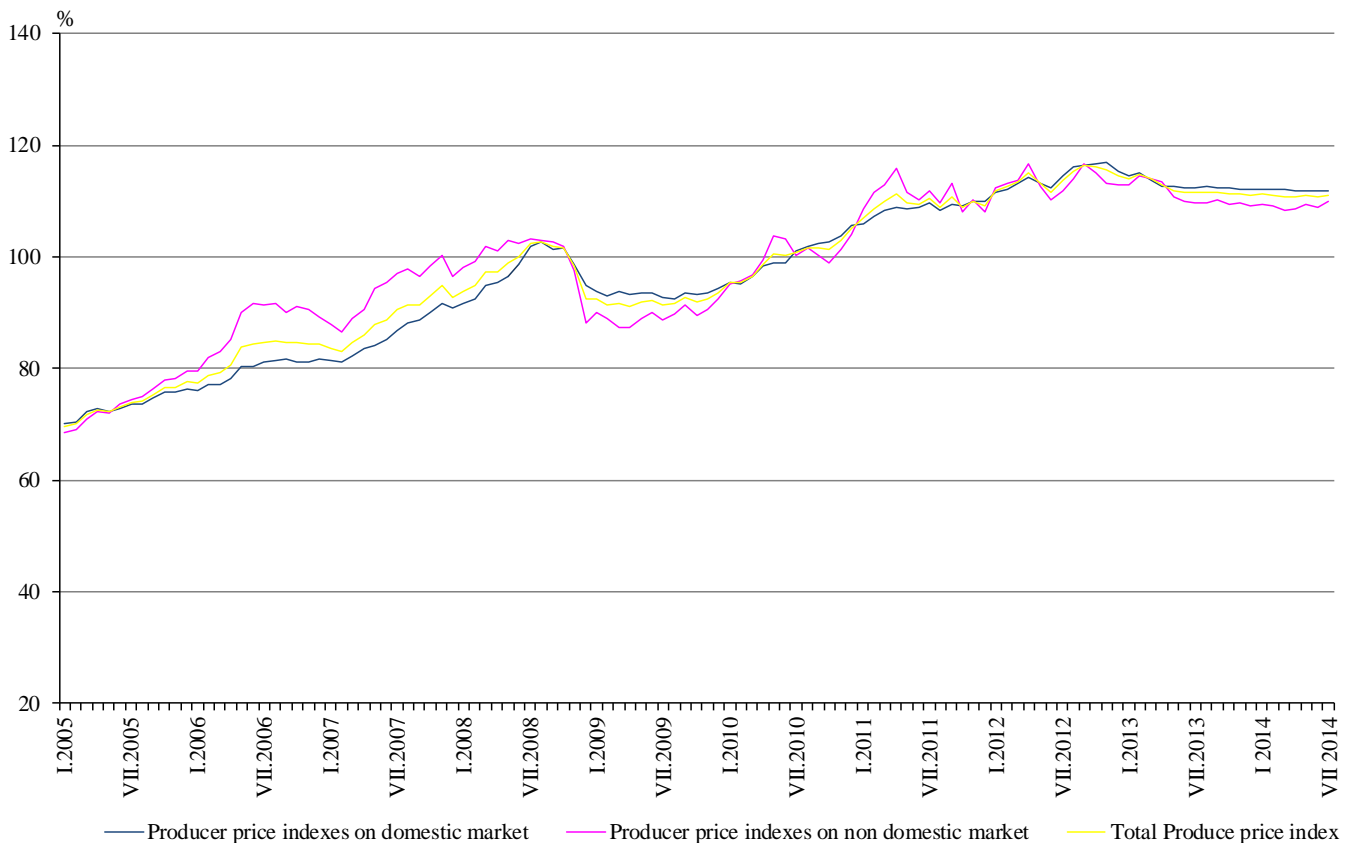

Total Producer Price Index in July 2014 decreased by 0.4% comparing to the same month of 2013.

In the manufacturing, the prices rose by 0.5% compared to July 2013. More significant prices increases were seen in the manufacture of tobacco products by 4.7%, in the manufacture wearing apparel by 2.7% and in the manufacture of beverages by 2.6%, while the producer prices fell in the manufacture of food products by 4.0%, in the manufacture of chemicals and chemical products by 1.8% and in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 0.7%.
