



PRODUCER PRICE INDICES IN INDUSTRY¹, NOVEMBER 2014

1. Producer Price Indices on Domestic Market²

Producer Price Index on Domestic Market in November 2014 decreased by 0.6% compared to the previous month. The domestic prices fell in the manufacturing by 1.1% and in the mining and quarrying industry by 0.2%, while in the electricity, gas, steam and air conditioning supply the prices rose by 0.2%.

In the manufacturing³, compared to the previous month the prices went down in the manufacture of other non-metallic mineral products by 0.2%, in the manufacture of food products and in the manufacture of textiles by 0.1%, while a price increase was reported in the manufacture of computer, electronic and optical products by 1.0%, in the repair and installation of machinery and equipment by 0.7% and in the manufacture of chemicals and chemical products by 0.5%.

Producer Price Index on Domestic Market in November 2014 increased by 0.3% compared to the same month of 2013. The domestic prices rose in the electricity, gas, steam and air conditioning supply by 3.2%, while prices decreases were registered in the manufacturing by 1.4% and in the mining and quarrying industry by 0.5%.

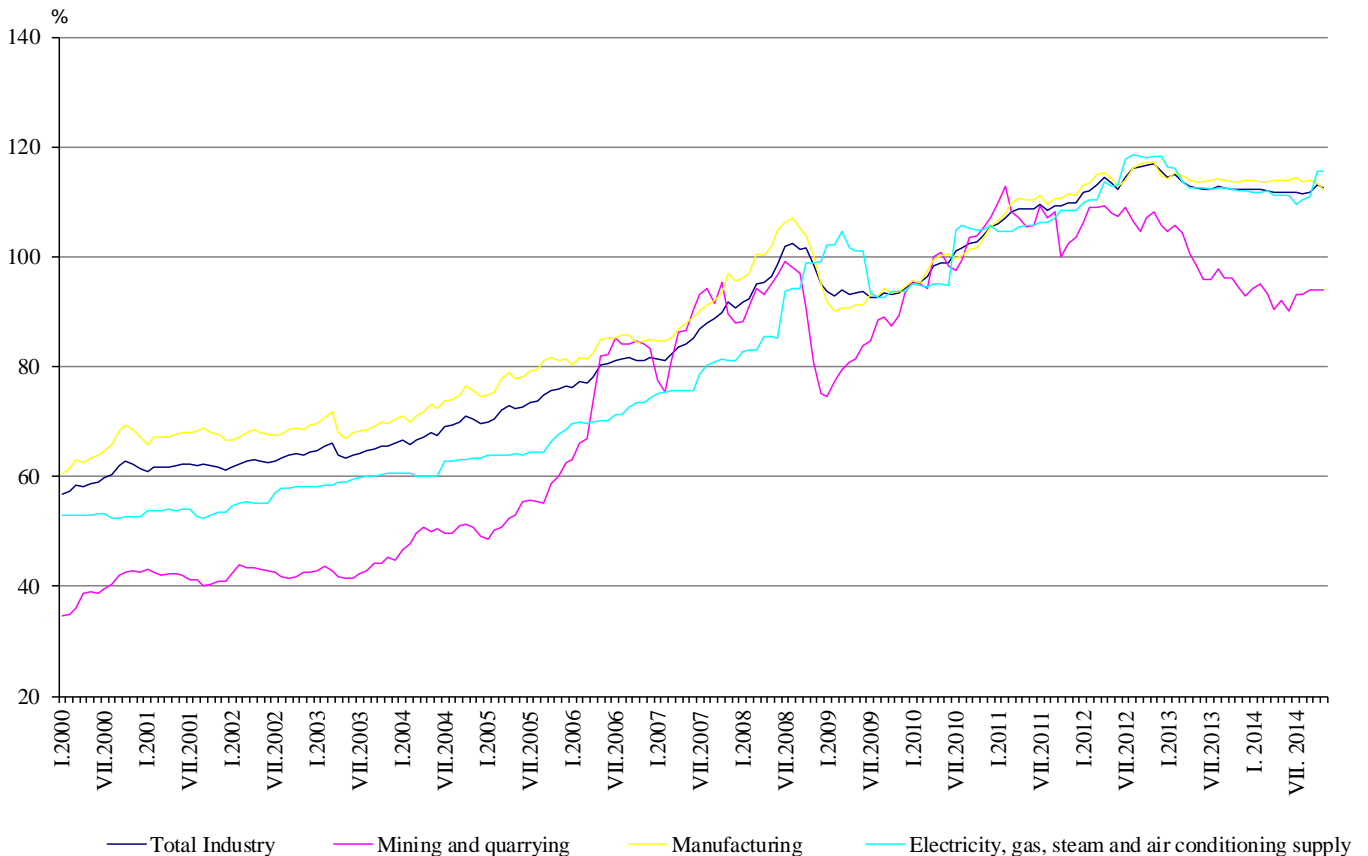
In the manufacturing compared to November 2013, a price decrease was reported in the manufacture of food products by 2.3%, in the manufacture of textiles by 0.9%, in the printing and reproduction of recorded media and in the manufacture of chemicals and chemical products by 0.6%. The prices increases were seen in the manufacture of tobacco products by 5.2%, in the manufacture of motor vehicles, trailers and semi-trailers by 4.1% and in the repair and installation of machinery and equipment by 3.1%.

¹Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

²Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

2. Total Producer Price Indices in Industry¹

Total Producer Price Index in Industry in November 2014 decreased by 0.5% compared to the previous month. Lower prices were registered in the manufacturing by 0.8%, in the mining and quarrying industry the prices rose by 1.1%, while in the electricity, gas, steam and air conditioning supply the prices did not change.

In the manufacturing², more significant prices decreases were seen in the manufacture of food products and in the manufacture of other non-metallic mineral products by 0.1%, while prices increases were reported in the manufacture of other transport equipment by 0.7%, in the manufacture of computer, electronic and optical products and in the repair and installation of machinery and equipment by 0.6%.

¹ Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year.

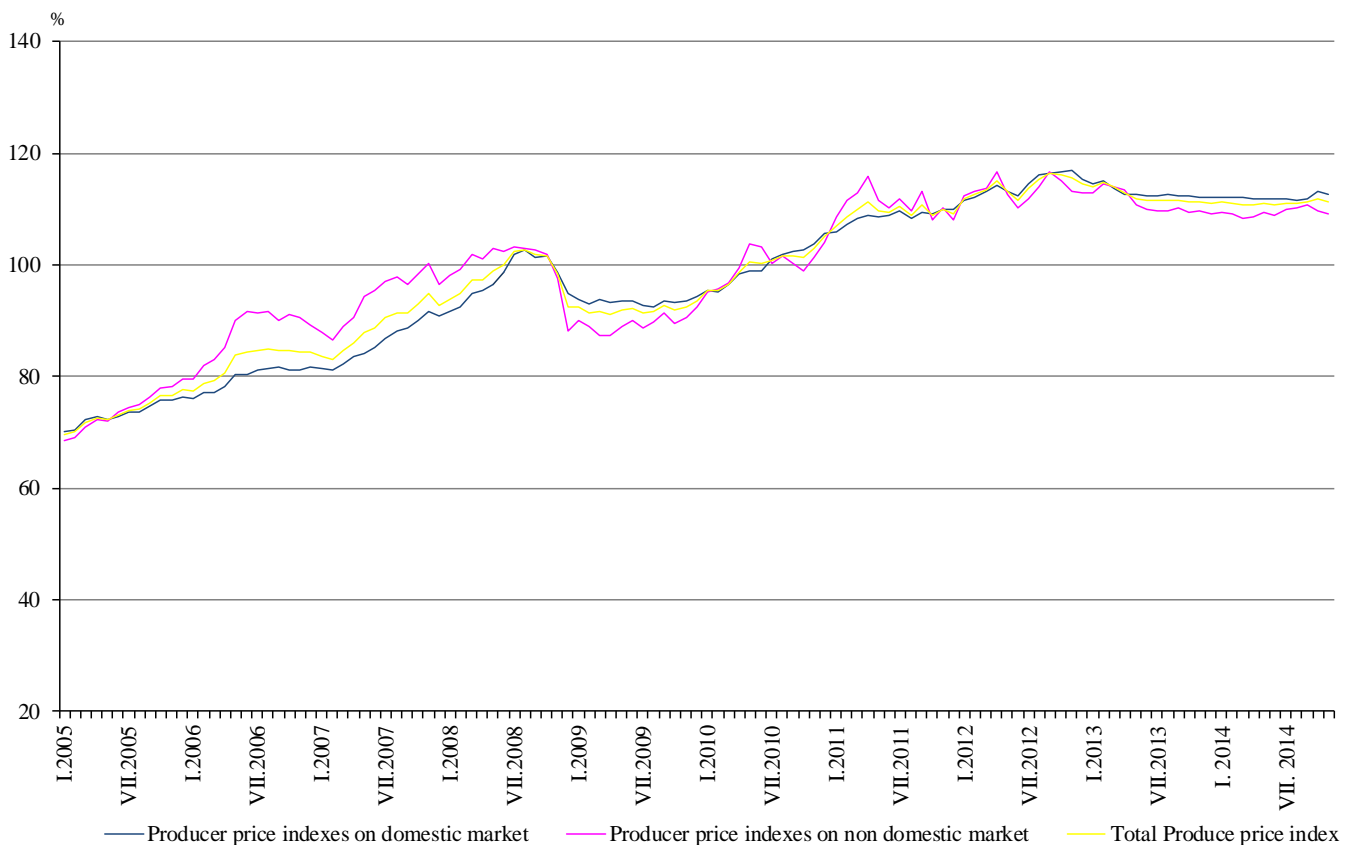

Total Producer Price Index in November 2014 remained at the level of the same month of 2013.

In the manufacturing, the prices fell by 1.1% compared to November 2013. More significant prices decreases were seen in the manufacture of food products by 2.1%, in the printing and reproduction of recorded media and in the manufacture of chemicals and chemical products by 0.4%, while the producer prices went up in the manufacture of other transport equipment by 5.7%, in the manufacture of tobacco products by 4.0% and in the manufacture of wearing apparel by 3.4%.
