



## PRODUCER PRICE INDICES IN INDUSTRY<sup>1</sup>, JULY 2015

### 1. Producer Price Indices on Domestic Market<sup>2</sup>

**Producer Price Index on Domestic Market** in July 2015 decreased by 0.5% compared to the previous month. The domestic prices fell in the manufacturing by 0.3%, in the mining and quarrying industry and in the electricity, gas, steam and air conditioning supply by 0.8%.

In the manufacturing<sup>3</sup>, compared to the previous month the prices went down in the manufacture of basic metals by 1.8%, in the manufacture of fabricated metal products, except machinery and equipment and in the manufacture of electrical equipment by 0.4%, while a price increase was reported in the manufacture of textiles by 0.7%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials and in the manufacture of rubber and plastic products by 0.5%.

**Producer Price Index on Domestic Market** in July 2015 decreased by 0.7% compared to the same month of 2014. The domestic prices fell in the manufacturing by 3.2% and in the mining and quarrying industry by 0.7%, while prices increases were registered in the electricity, gas, steam and air conditioning supply by 3.8%.

In the manufacturing compared to July 2014 the prices fell in the manufacture of fabricated metal products, except machinery and equipment by 0.9%, in the manufacture of other non-metallic mineral products by 0.8%. The prices increases were reported in the manufacture of tobacco products by 3.0%, in the manufacture of computer, electronic and optical products and in the manufacture of machinery and equipment n.e.c. by 2.8%.

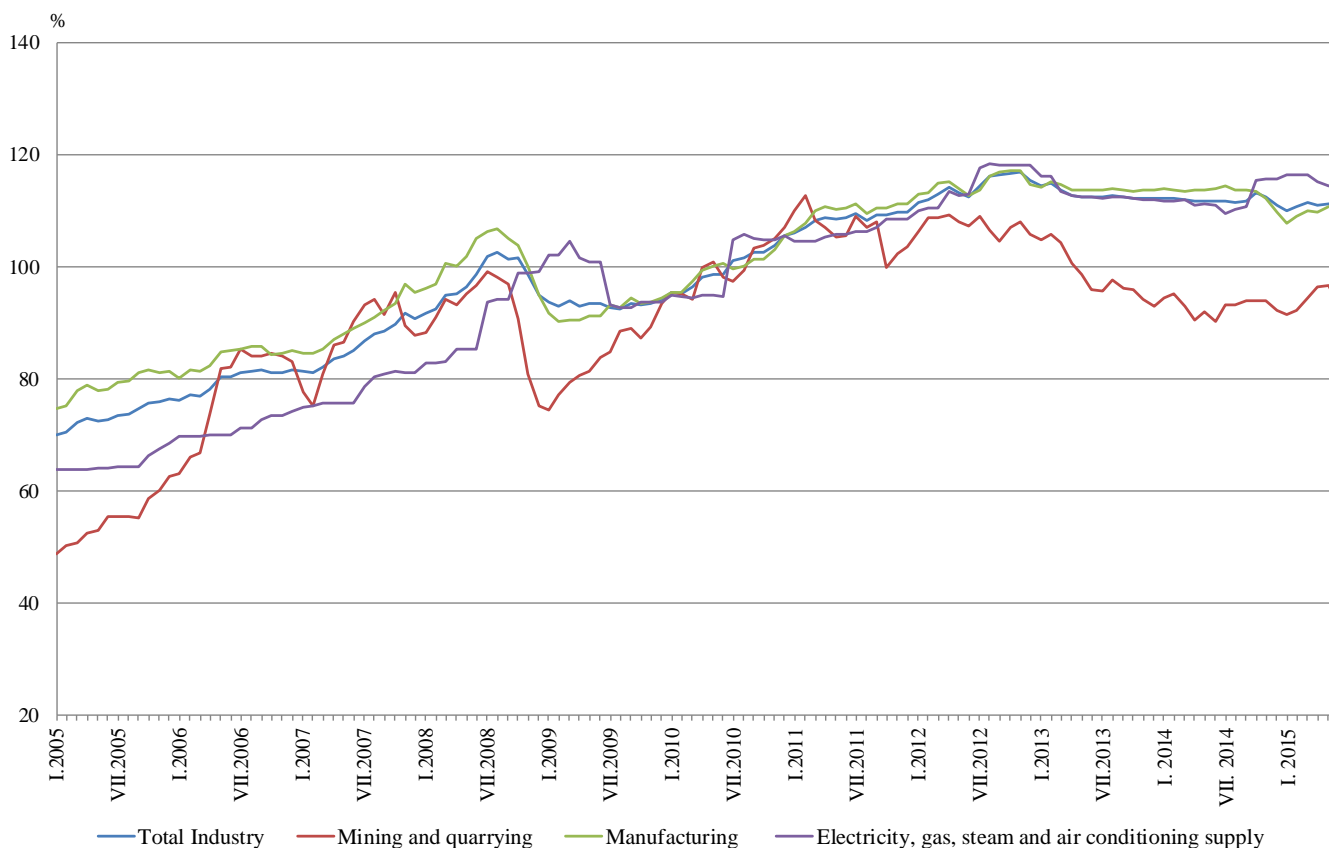
<sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

<sup>2</sup> Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

## 2. Total Producer Price Indices in Industry<sup>1</sup>

**Total Producer Price Index in Industry** in July 2015 decreased by 0.5% compared to the previous month. Lower prices were registered in the manufacturing by 0.5% and in the electricity, gas, steam and air conditioning supply by 0.9%, while in the mining and quarrying industry the prices rose by 4.4%.

In the manufacturing<sup>2</sup>, more significant prices decreases were seen in the manufacture of basic metals by 1.8% and in the manufacture of electrical equipment by 0.3%, while prices increases were reported in the manufacture of chemicals and chemical products by 1.3% and in the manufacture of basic pharmaceutical products and pharmaceutical preparations by 1.1%.

**Total Producer Price Index** in July 2015 decreased by 0.9% compared to the same month of 2014.

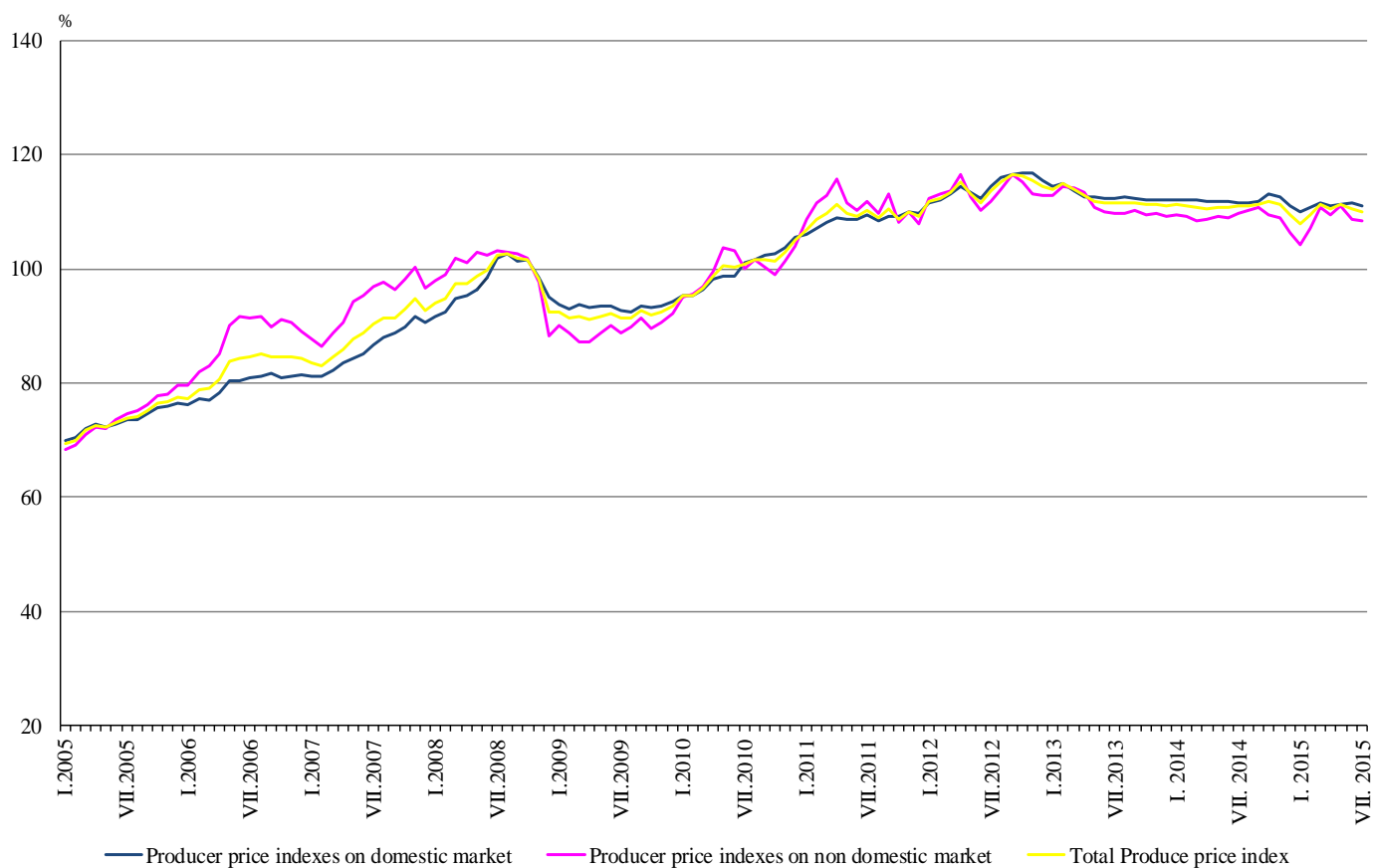
<sup>1</sup> Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year.

In the manufacturing, the prices fell by 2.4% compared to July 2014. More significant prices decreases were seen in the manufacture of other non-metallic mineral products by 0.8%, in the manufacture of beverages by 0.4% and in the manufacture of food products by 0.2%, while the producer prices went up in the manufacture of other transport equipment by 7.7%, in the manufacture of textiles by 6.3% and in the manufacture of chemicals and chemical products by 5.6%.
