



PRODUCER PRICE INDICES IN INDUSTRY¹, JULY 2016

1. Total Producer Price Indices in Industry²

Total Producer Price Index in Industry in July 2016 decreased by 0.2% compared to the previous month. Lower prices were registered in the mining and quarrying industry by 1.2%, in the manufacturing by 0.2%, and in the electricity, gas, steam and air conditioning supply by 0.3%.

In the manufacturing³, more significant prices decreases were seen in the other manufacturing by 0.2% and in the manufacture of electrical equipment by 0.1%, while prices increases were reported in the manufacture of basic metals by 1.9% and in the manufacture of wearing apparel by 0.8%.

Total Producer Price Index in July 2016 decreased by 4.3% compared to the same month of 2015. The prices fell in the mining and quarrying industry by 9.4%, in the manufacturing by 4.0% and in the electricity, gas, steam and air conditioning supply by 4.8%.

More significant prices decreases were seen in the manufacture of basic metals by 5.6%, in the manufacture of paper and paper products by 3.1% and in the manufacture of chemicals and chemical products by 2.7%, while the producer prices rose in the repair and installation of machinery and equipment by 3.2%, in the manufacture of tobacco products by 2.4% and in the manufacture of wood and of products of wood and cork, except furniture by 2.1%.

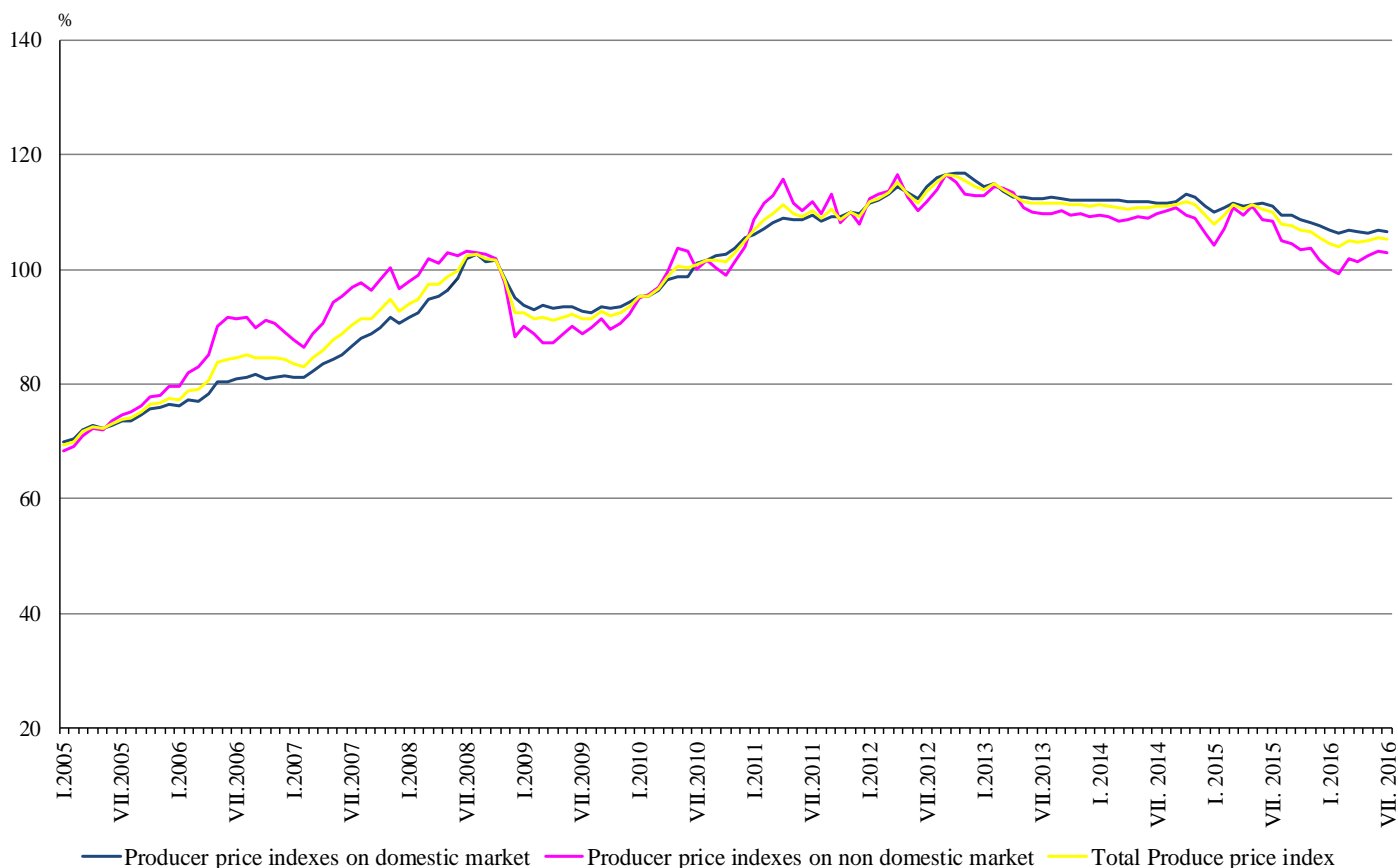
¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

² Total Producer Price Index is calculated from Producer Price Index on Domestic Market and Producer Price Index on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2010).

2. Producer Price Indices on Domestic Market¹

Producer Price Index on Domestic Market in July 2016 decreased by 0.1% compared to the previous month. The domestic prices fell in the manufacturing and in the electricity, gas, steam and air conditioning supply by 0.2%, while the prices rose in the mining and quarrying industry by 2.4%.

In the manufacturing², compared to the previous month the prices declined in the manufacture of chemicals and chemical products by 1.2% and in the manufacture of wood and of products of wood and cork, except furniture by 0.6%, while a price increase was reported in the manufacture of basic metals by 2.4% and in the manufacture of wearing apparel by 0.6%.

¹ Producer Price Indices on domestic market are calculated at constant base (2010) weighed with turnover structure on domestic market.

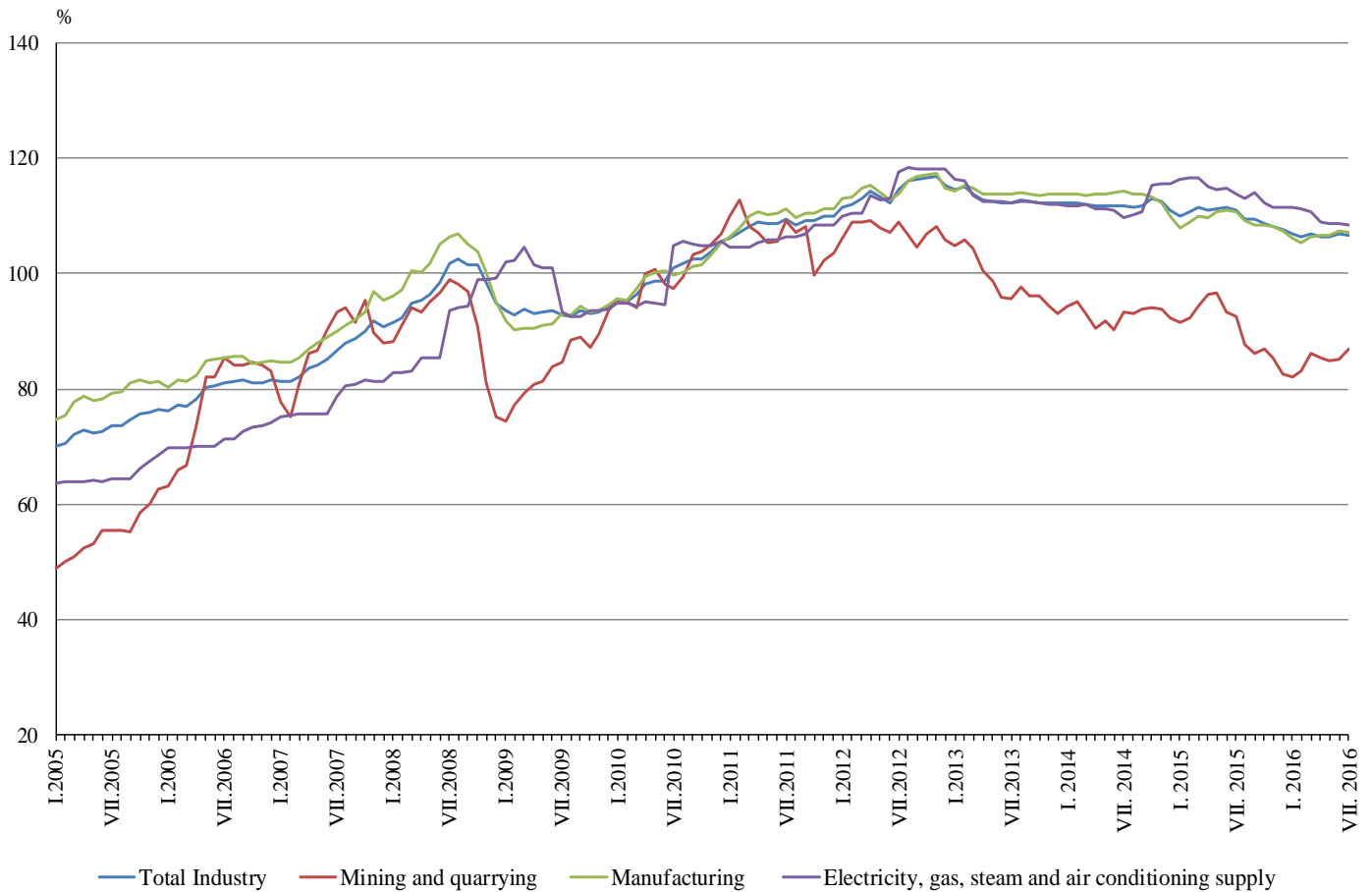

Producer Price Index on Domestic Market in July 2016 decreased by 3.8% compared to the same month of 2015. The domestic prices fell in the mining and quarrying industry by 6.0%, in the manufacturing by 3.3% and in the electricity, gas, steam and air conditioning supply by 4.7%.

In the manufacturing compared to July 2015 the prices fell in the manufacture of basic metals by 5.6%, in the manufacture of chemicals and chemical products by 4.7% and in the manufacture of rubber and plastic products by 2.0%. The prices increases were reported in the manufacture of computer, electronic and optical products, in the repair and installation of machinery and equipment by 3.7% and in the manufacture of tobacco products by 2.4%.

3. Producer Price Indices on Non-domestic Market¹

Producer Price Index on Non-domestic Market in July 2016 fell by 0.4% compared to the previous month.

In the manufacturing² compared to the previous month the non-domestic prices went down by 0.2%. More significant prices decreases were reported in the manufacture of food products by 0.7% and in the manufacture of electrical equipment by 0.1%, while the prices rose in the manufacture of basic metals by 1.8% and in the manufacture of wood and of products of wood and cork, except furniture by 1.5%.

Producer Price Index on Non-domestic Market in July 2016 decreased by 5.2% compared to the same month of 2015.

In the manufacturing, the prices fell by 4.8% compared to July 2015. The non-domestic prices went down in the manufacture of paper and paper products by 9.7% and in the manufacture of basic metals by 5.6%. The prices rose in the manufacture of wood and of products of wood and cork, except furniture by 6.7% and in the manufacture of leather and related products by 3.0%.

¹ Producer Price Indices on non-domestic market are calculated at constant base (2010) weighed with turnover structure on non-domestic market.
