



## PRODUCER PRICE INDICES IN INDUSTRY<sup>1</sup>, JUNE 2018

### 1. Total Producer Price Indices in Industry<sup>2</sup>

**The Total Producer Price Index in Industry** in June 2018 rose with 0.8% compared to the previous month. Higher prices were registered in the mining and quarrying industry by 5.3% in manufacturing by 0.8% and in the electricity, gas, steam and air conditioning supply by 0.1%.

In the manufacturing<sup>3</sup>, more significant increase in prices were reported in the manufacture of basic metals by 2.7%, as well as in the reparation and installation of machinery and equipment by 1.3%, while prices went down in the manufacture of tobacco products by 0.6% in the manufacture of wood and of products of wood and cork, except furniture - by 0.1%.

**The Total Producer Price Index** in June 2018 increased by 6.8% compared to the same month of 2017. The prices rose in the mining and quarrying industry by 10.2%, in the electricity, gas, steam and air conditioning supply by 9.0% and in manufacturing by 6.0%.

In the manufacturing more significant increase in prices were seen in the manufacture of basic metals by 14.2%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 5.7% and in the manufacture of paper and paper products by 4.5%, while the producer prices dropped in the manufacture of tobacco products by 1.0% and in the manufacture of chemicals and chemical products by 0.6%.

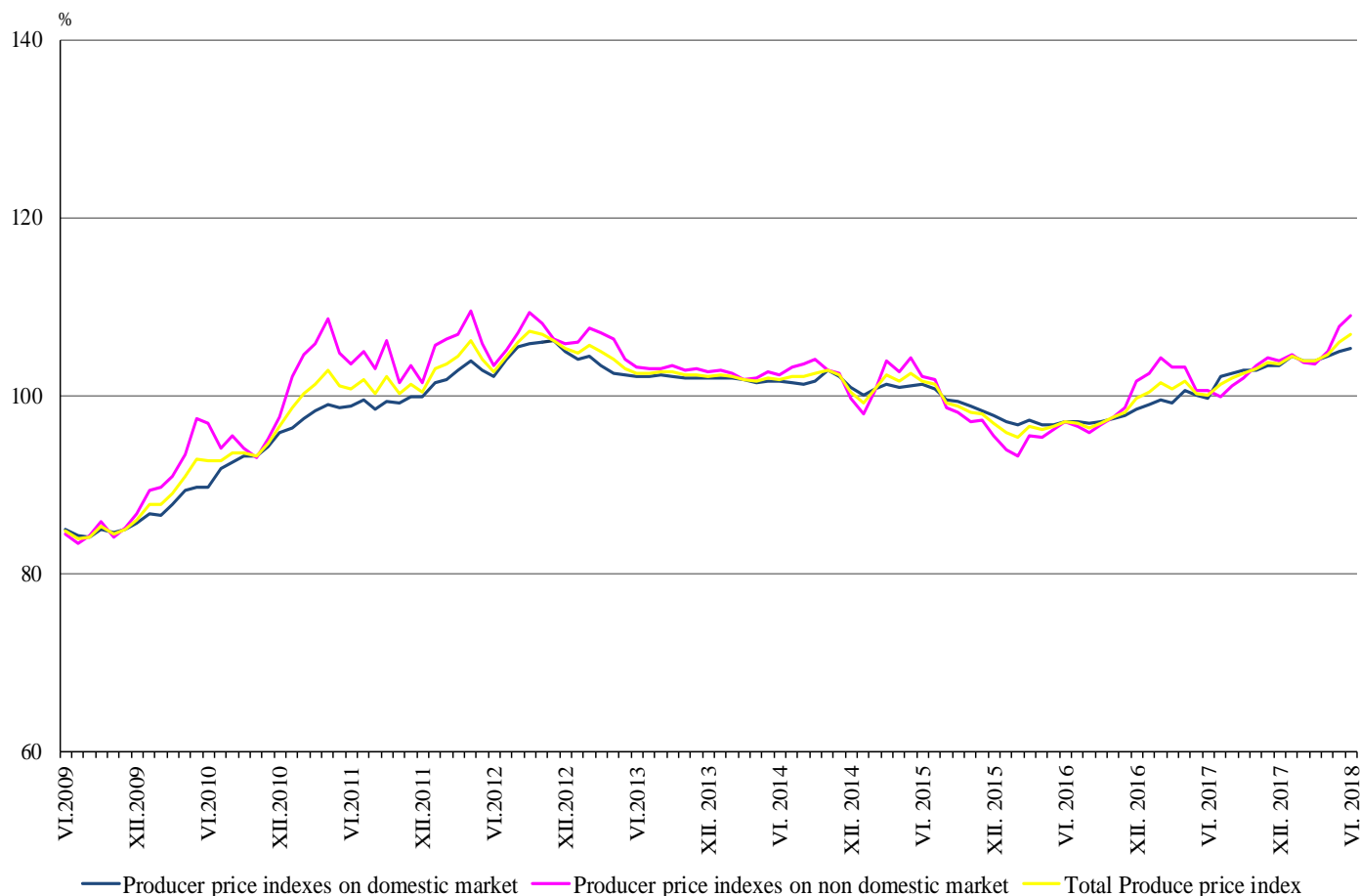

<sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

<sup>2</sup> Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

## 2. Producer Price Indices on Domestic Market<sup>1</sup>

**Producer Price Index on Domestic Market** in June 2018 increased by 0.5% compared to the previous month. The domestic prices went up in the mining and quarrying industry by 3.5%, in manufacturing by 0.5%, while the prices in the electricity, gas, steam and air conditioning supply remained the same.

In the manufacturing<sup>2</sup>, compared to the previous month the prices went up in the manufacture of basic metals by 3.6% and in the reparation and installation of machinery and equipment by 1.9%. The domestic prices went down in the manufacture of tobacco products by 1.0% and in the manufacture of chemicals and chemical products by 0.6%.

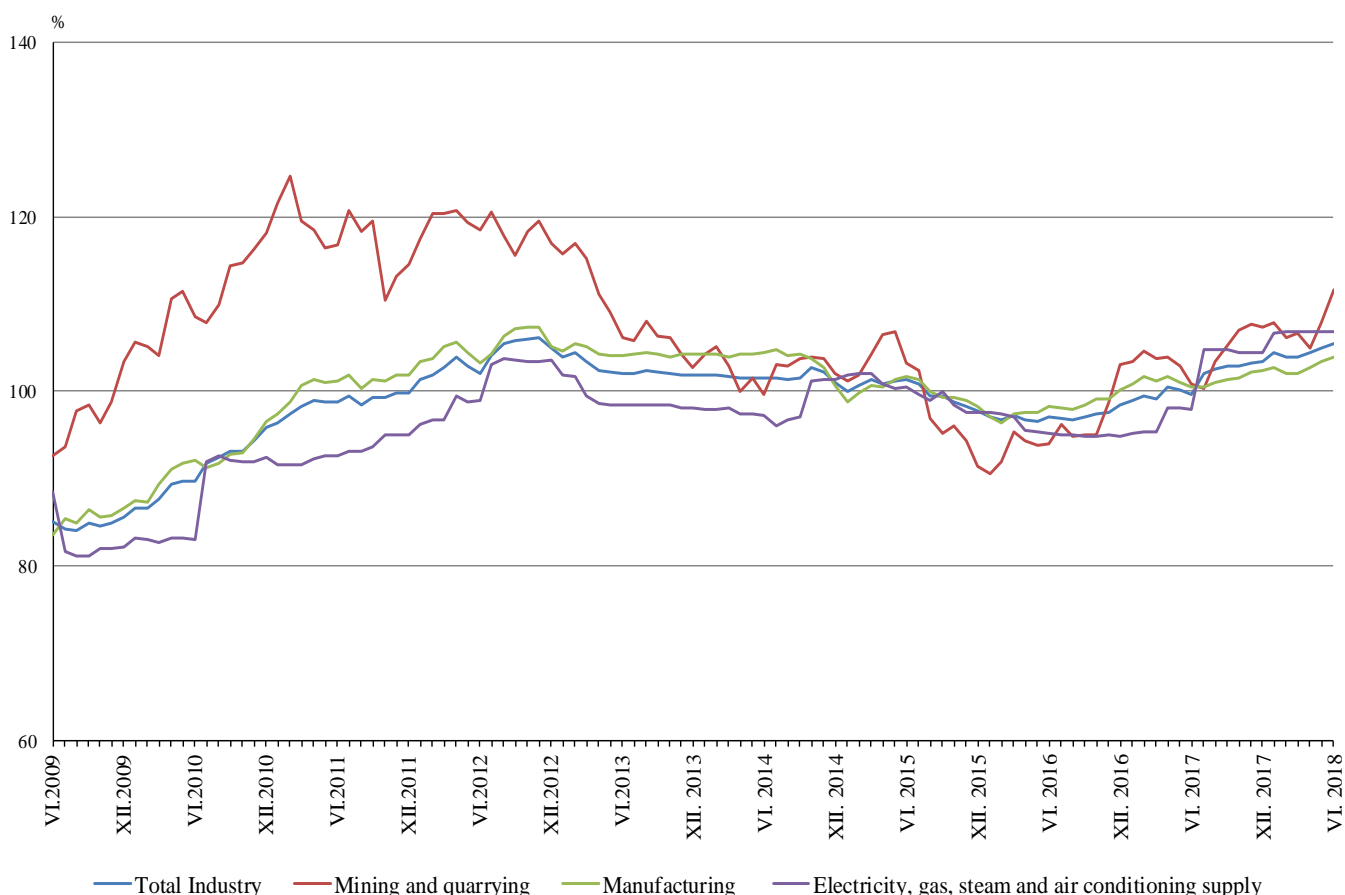

**Producer Price Index on Domestic Market** in June 2018 increased by 5.7% compared to the same month of 2017. The prices rose in the mining and quarrying industry by 10.7%, in the electricity, gas, steam and air conditioning supply by 9.0% and in manufacturing by 3.4%.

In the manufacturing in June 2018 compared to June 2017 the prices went up in the manufacture of basic metals by 10.9%, in the manufacture of furniture by 4.6% and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 4.0%. A decrease in the prices was reported in the manufacture of rubber and plastic products and in the manufacture of tobacco products - both by 0.7%, as well as in other manufacturing and in the manufacture of chemicals and chemical products - both by 0.4%.

### 3. Producer Price Indices on Non-domestic Market<sup>1</sup>

**Producer Price Index on Non-domestic Market** in June 2018 increased by 1.2% compared to the previous month.

In the manufacturing<sup>2</sup> the non-domestic prices increased by 1.0%. More significant price increase were reported in manufacture of basic metals by 2.5%, in the manufacture of food products - by 1.9% and in the manufacture of chemicals and chemical products by 1.0%, while prices went down in manufacturing of other non-metallic mineral products by 0.3%, and in other manufacturing by 0.1%.

**Producer Price Index on Non-domestic Market** in June 2018 increased by 8.3% compared to the same month of 2017.

In the manufacturing, the prices went up by 8.5%. The non-domestic prices rose in the manufacture of basic metals by 14.8%, in the manufacture of wood and of products of wood and cork, except furniture, manufacture of articles of straw and plaiting materials by 7.9% and in the manufacture of leather and related products by 6.2%. The prices fell in the manufacture of tobacco products by 1.9% and in the manufacture of furniture by 1.4%.
