



PRODUCER PRICE INDICES IN INDUSTRY^{1,2}, APRIL 2021

1. Total Producer Price Indices in Industry³

The Total Producer Price Index in Industry in April 2021 increased by 0.3% compared to the previous month. Higher prices were registered in the electricity, gas, steam and air conditioning supply by 0.6%, in manufacturing by 0.2%, while the prices decreased in mining and quarrying industry by 1.5%.

Prices went up significantly in the manufacture of rubber and plastic products by 4.6%, in the manufacture of wood and of products of wood and cork, except furniture, manufacture of articles of straw and plaiting materials by 3.0%, and in the manufacture of chemicals and chemical products by 2.2%. Prices fell in the manufacture of basic metals by 4.0%.

The Total Producer Price Index in April 2021 increased by 9.8% compared to the same month of 2020. The prices went up in the mining and quarrying industry by 20.0%, in manufacturing by 10.9%, and in the electricity, gas, steam and air conditioning supply by 5.5%.

In manufacturing, more compelling increase in prices was reported in the manufacture of basic metals by 31.3%, in the manufacture of rubber and plastic products by 9.4%, in the manufacture of chemicals and chemical products by 8.6% and in the manufacture of food products by 6.8%. Prices fell in the manufacture of textiles by 2.0% and in the manufacture of computer, electronic and optical products by 0.6%.

¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.


² In the text are not quoted the activities that are confidential according to the Law on Statistics and in this way they are statistical secrecy.

³ Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

2. Producer Price Indices on Domestic Market¹

Producer Price Index on Domestic Market in April 2021 increased by 0.9% compared to the previous month. The domestic prices went up in the manufacturing by 1.2% and in electricity, gas, steam and air conditioning supply by 0.5%, while the prices went down in the mining and quarrying industry by 0.2%.

In the manufacturing, compared to the previous month prices went up in manufacture of chemicals and chemical products by 3.5%, in manufacture of rubber and plastic products by 2.8% and in the manufacture of electrical equipment by 1.8%.

¹ Producer Price Indices on domestic market are calculated at constant base (2015) weighed with turnover structure on domestic market.





Producer Price Index on Domestic Market in April 2021 increased by 6.8% compared to the same month of 2020. Prices went up in the mining and quarrying industry by 21.6%, in manufacturing by 7.8%, and in the electricity, gas, steam and air conditioning supply by 3.9%.

In manufacturing compared to April 2020, more compelling price growth was reported in the manufacture of basic metals by 36.2%, in manufacture of chemicals and chemical products by 15.3%, in the manufacture of rubber and plastic products by 7.8% and in the manufacture of electrical equipment by 6.7%. More significant price decrease was seen in the manufacture of wearing apparel by 2.2%.




Figure 2. Producer Price Indices on Domestic Market in Industry (2015 = 100)

3. Producer Price Indices on Non-domestic Market¹

Producer Price Index on Non-domestic Market in April 2021 fell by 0.7% compared to the previous month, and rose by 14.6% compared to the same month of 2020.

¹ Producer Price Indices on non-domestic market are calculated at constant base (2015) weighed with turnover structure on non-domestic market.
