PRODUCER PRICE INDICES IN INDUSTRY^{1,2}, APRIL 2022

1. Total Producer Price Indices in Industry³

The Total Producer Price Index in Industry in April 2022 increased by 3.3% compared to the previous month. Higher prices were registered in the mining and quarrying industry by 6.4%, in electricity, gas, steam and air conditioning supply by 5.2% and in the manufacturing by 2.3%.

A more compelling increase in prices was seen in the manufacture of food products by 5.3% in the manufacture of basic metals by 5.0%, in the manufacture of leather and related products by 4.7% and in the manufacture of paper and paper products by 3.1%.

The Total Producer Price Index in April 2022 rose by 40.2% compared to the same month of 2021. The prices went up in the electricity, gas, steam and air conditioning supply by 93.7%, in the manufacturing by 24.9% and in the mining and quarrying industry by 22.2%.

In the manufacturing, a more compelling increase in prices was reported in the manufacture of chemicals and chemical products by 34.4%, in the manufacture of basic metals by 30.9%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 29.8%, in the manufacture of paper and paper products by 27.1%, in the manufacture of fabricated metal products, except machinery and equipment by 23.4%, in the manufacture of food products by 22.3%.

¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of total industrial production.

² In the text are not quoted the activities that are confidential according to the Law on Statistics and in this way they are statistical secrecy.

³ Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Nondomestic Market weighted with the turnover structure on the domestic and the non-domestic market to the total value of turnover in the base year (2015).




Figure 1. Total Producer Price Indices in Industry (2015 = 100)

2. Producer Price Indices on Domestic Market¹

The Producer Price Index on the Domestic Market in April 2022 increased by 4.1% compared to the previous month. The domestic prices went up in the electricity, gas, steam and air conditioning supply by 5.7%, in the mining and quarrying industry by 4.6% and in the manufacturing by 2.7%.

In the manufacturing, compared to the previous month, prices rose in the manufacture of basic metals by 7.2%, in the manufacture of paper and paper products by 4.2% and in the manufacture of food products by 4.0%. Prices fell in the manufacture of motor vehicles, trailers and semi-trailers by 0.2%.

¹ Producer Price Indices on domestic market are calculated at constant base (2015) weighed with turnover structure on domestic market.

The Producer Price Index on the Domestic Market in April 2022 went up by 49.8% compared to the same month of 2021. Prices rose in the electricity, gas, steam and air conditioning supply by 90.5%, in the manufacturing by 28.1% and in the mining and quarrying industry by 23.0%.

In the manufacturing, compared to April 2021, a more compelling price increase was reported in the manufacture of chemicals and chemical products by 51.8%, in the manufacture of basic metals by 45.9% and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 41.4%.




Figure 2. Producer Price Indices on Domestic Market in Industry (2015 = 100)

3. Producer Price Indices on Non-domestic Market¹

The Producer Price Index on the Non-domestic Market in April 2022 grew by 1.9% compared to the previous month, while compared to the same month of 2021, the prices increased by 25.8%.

¹ Producer Price Indices on non-domestic market are calculated at constant base (2015) weighed with turnover structure on non-domestic market.
